RESOLUTION 2023-64
SETTLEMENT OF APPELLATE DIVISION DOCKET NUMBER A-3966-21, IN THE
MATTER OF NEW JERSEY HIGHLANDS LLC APPLICATION FOR CLINICAL
REGISTRANT PERMIT

WHEREAS, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, on August 24, 2022, New Jersey Highlands LLC filed a notice of appeal in the New Jersey Appellate Division, docket number A-3966-21; and

WHEREAS, New Jersey Highlands alleges that on October 8, 2021, it submitted an application for a clinical registrant permit pursuant to N.J.S.A. 24:6I-7.3, and alleges that the Commission was required to make a determination on the application no later than 90 days from receipt of their application; and

WHEREAS, the Commission and New Jersey Highlands, LLC have tentatively agreed to amicably resolve the pending appeal; and

WHEREAS, the Commission now votes to act consistent with the discussion had and the recommendation made in executive session;

NOW, THEREFORE, BE IT RESOLVED, by the New Jersey Cannabis Regulatory Commission, that the attached consent order is hereby approved for submission to the Superior Court, Appellate Division. It is **FURTHER RESOLVED** that the Chair and Executive Director have joint authority to sign the final consent order on behalf of the Commission.
