Noting the cancellation of the May 4 public meeting, I am submitting this comment with the request that the June 1 agenda will include such notice. My team and I believe that additional delays in accepting applications for these license types not only threaten the viability of these logistics licenses but also disadvantage upcoming standalone cultivators and manufacturers. These independent license holders may not have the resources or the expertise to support the necessary infrastructure and operations to compete with established vertically integrated operators. We look forward to the opportunity to provide logistics support to the evolving supply chain and to advance the State's goal of building a robust and diverse regulated cannabis industry in New Jersey.

Some of you may know me from my work in this state with a certain civil rights organization, however today, I am here speaking as the owner of a consultancy which supports the cannabis industry among others. I represent an awardee from the 2019 RFA which was approved for vertical licensure. This group's facilities have been inspected by the CRC with no with no additional actions required to meet compliance. With a \$12 million investment in the company, the organization is ready to serve the needs of patients in the State of New Jersey. However, we are unable to secure a meeting with any staff at the CRC in order to alleviate the concerns the regulator may or may not have. This company is South-Jersey owned, is planning to hire local, and is keen to play their part in contributing to the Social Equity Excise Fee ("SEEF"). By way of these comments, I am requesting a meeting with CRC as soon as possible in order to rectify this issue and open the doors to this facility.

		I would also like to bring to the attention of the CRC a concern that I and many of peers share regarding the voting records of some Commission members. When cannabis was first legalized in New Jersey for adult-use, there was an understanding that it would be a social equity-minded industry. This means, allow the Black and Brown individuals who have been historically arrested, incarcerated, and villainized, to take part in this industry with a level of priority. I am disheartened to see some of our Commission members voting against Black and Brown local business owners who share the same social justice minded goals for our cannabis industry. Jeffrey Walsh	4/14/23	I am writing to express my concerns regarding the elongated process as well as the secrecy surrounding the status of legalizing adult-use cannabis in New Jersey. As a concerned citizen and prospective licensee, I believe that the lack of transparency in the decision-making and review process of the NJ CRC is causing significant delays in the rollout of adult-use cannabis sales in the state, which is in turn causing NJ to lose out on much-needed tax revenue. It's my understanding the commission has been reluctant to release detailed status and progress updates for adult-use dispensaries currently in the process. This lack of transparency is creating significant delays in opening and unnecessary financial and logistical roadblocks for businesses trying to enter the cannabis market. Moreover, the delays in the rollout of adult-use cannabis sales are causing the state to miss out on significant tax revenue. Legalizing cannabis was intended to generate significant tax revenue for the state, but delays in the licensing process and the continued operation of the illicit market are causing the state to lose out on millions of dollars in potential revenue.

The only ones benefiting from these delays are the large MSO companies and medicinal dispensaries permitted to operate as adult-use. This increases the need for transparency as it postulates favoritism and influence from these organizations.

I understand the need for approvals prior to providing a license but being there is no public discussion prior to license approval, this could be done on a weekly basis. The board can vote on licenses as investigations are completed so companies aren't waiting for a monthly meeting that could possibly be canceled. In addition to a few suggestions below, I believe this will speed up the process of opening new adult-use facilities and significantly impact NJ tax revenue.

Additional suggestions:

- Once a license is approved by the CRC board, the facility should be able to open and operate on a probationary status until documents are received. They will be provided a virtual document to store onsite stating their approval/acceptance of the license. This will give the CRC time to do walk-throughs and see the operation as it would function with product onsite and staff interacting with customers.
- Board should approve licenses on a weekly basis and as their investigations are completed.
- Quarterly or once every other month meeting covering larger topics and announcements. We understand these meetings take time to plan and it slows down the review and approval of applications. Splitting the two agendas, frees up time to review more applicants, supplies licenses in real-time, and drives more growth in the industry.
- Continued prioritization based on the current ranking system with clear communication as to how this prioritization is being applied.
- Badging should transfer between companies/organizations and should follow the individual. As we understand it, if a budtender or employee was to transfer companies, they would have to reapply for a new badge and restart the process.
- Badging should be available prior to employment being received or licenses being issued. This gives the facilities and future cannabis employees the ability to get their documentation/staffing aligned and not delay openings.

I urge the New Jersey Cannabis Regulatory Commission to take immediate steps to increase transparency in the decision-making process, ensure that licensing is carried out in a timely and efficient manner, and take proactive steps to minimize the delays in the rollout of adult-use cannabis sales. The continued delays are causing significant harm to the state's economy and are

		putting New Jersey at a competitive disadvantage with neighboring states that have already legalized adult-use cannabis. Thank you for your attention Jeff Walsh
