		I stand before you today, not just as Jaraun Khaim Wright, co-founder and managing partner of The Banc Street Collective, but as a lifelong resident of Morris County, an advocate for social equity, and a steward of transparency in the rapidly growing cannabis industry.
		The promise of the New Jersey Cannabis Regulatory Commission is to ensure social justice and equity within this industry. However, when I look at the landscape of how business is being conducted at the municipal level, I am forced to ask: Is this promise being upheld?
		The bedrock of the NJCRC's mission is to redress past wrongs - the countless lives upended by the unjust war on drugs and the immeasurable opportunities missed by communities disproportionately affected by these past laws. Yet, we find ourselves staring at the face of corruption in local municipalities that not only contradicts, but threatens to undermine this noble mission.
		The shadows of unscrupulous deals, of opaque licensing processes, and of a lack of equitable access to cannabis business opportunities are threatening to cast a permanent dark cloud over what should be a sunrise industry. This goes against the very essence of the Commission's commitment to fairness, transparency, and social equity.
		Corruption at any level is unacceptable. It is doubly so in an industry where the primary focus should be redressing past wrongs and empowering marginalized communities. It directly contradicts the idea of equity, robbing deserving entrepreneurs of their chance to participate in the cannabis market, thus perpetuating the cycle of exclusion that we aim to break.
		My question to our municipalities is simple: How can we truly foster diversity and inclusion in the cannabis industry when back-room deals shut the door on those who have borne the brunt of the injustices of prohibition? How can we champion social equity when the wheels of progress are

We began our company in 2017, located in the state of Oregon. We produce various products; chews (gummies), tinctures, shatter, vapes, etc. Our current business in Oregon has grown to around 50 employees and has been one of the Oregon market's top-selling chews (gummies). In 2022, we moved back to New Jersey to expand our business and open a second manufacturing location in our home state. I am Robert Wilder Sampson with Mule Extracts LLC, one of the owners and founders living in New Jersey. I am reaching out concerning our manufacturing conversion application and the status of the review process. Our conditional license was approved on 02/22/23, and we submitted all our paperwork for the conversion application. We also have full approval from our municipality to start manufacturing at our facility and operate as a class two cannabis manufacturer. As of last week, we have also been approved by the Planning Board in the Township of our facility. We have received a Cure letter for our Conversion application for our Labor Peace Agreement. We have fixed that Cure letter and have obtained our Labor Peace Agreement; it was signed and filed with CRC on 4/11/23. We have been paying rent on our facility since March of 2022 last year. We would like an update on where we are in the process, if possible. We look forward to supporting our home state, creating a positive community within the industry, giving back, and supporting our local workforce and charities.
