<p>7/18/2023</p>	<p>Juan Umana</p>	<p>Dear Cannabis Regulatory Commission,</p> <p>I am writing to inquire about the status of our conversion application (Application ID 2915) from conditional to annual for our Class 5 Retail Micro-business license. My name is Juan Umana, and I am the owner of Urge New Jersey LLC, a NJ Certified Minority-Owned and Impact Zone business located at 941 Elizabeth Ave, Elizabeth, NJ.</p> <p>We submitted our conversion application on April 3, 2023, and we have followed the instructions provided by the CRC, including promptly undergoing the required criminal background checks. Both owners had their fingerprints taken at Identogo on May 26, 2023.</p> <p>Since then, we have not received any further communication, confirmation, or update regarding the progress of our application. As the completion of our store renovations approaches at the end of July, we find ourselves in a challenging position. We are currently incurring monthly expenses without any clarity on when we will be granted operational status.</p> <p>Additionally, we have reached out to prospective employees and extended employment proposals, but we are unable to proceed with hiring until we receive an update on our license. This uncertainty is impacting our ability to establish a timeline for opening and to provide economic opportunities for the community.</p> <p>Considering the importance of timely updates and the financial impact on our business, we kindly request that you provide us with an update on the review process and a tentative timeline for the completion of our application. This information will allow us to plan accordingly and make informed decisions regarding our operations and future employment.</p> <p>We greatly appreciate your attention to this matter and look forward to your prompt response. I had the opportunity to attend the CRC's virtual town hall for municipal officials - Mercer, Middlesex & Monmouth - on Wednesday, July 12, 2023, and I found it to be very helpful to learn about what other municipalities are experiencing in regards to adult-use cannabis licensing and operations. I have gained some ideas and "best practices" that I would like to present to my fellow Council members and implement in the Borough by the end of the year. I am appreciative of the education and training that is available to business owners and operators in the cannabis industry. These opportunities will be able to help them achieve economic growth and begin to build generational wealth that is lacking in marginalized communities. The information and resources provided by the Office of Diversity and Inclusion (ODI) demonstrates how social equity and racial justice are not just "talking points" or performative measures; ODI continues to lay the framework to empower disabled veterans, women, and other minority groups to be successful in the industry. What I would like to see are more resources and training available for municipal officials, in collaboration with the New Jersey State League of Municipalities. Due to the industry's recent entry in the state's economy, it is imperative that municipal officials - including elected members of the governing body - have the information and tools to implement an equitable industry in their communities, while enhancing economic growth. Even though the Borough of Eatontown is not considered an impact zone, we currently have social equity and diversely owned business applicants waiting to be approved for an annual license. 		<p>but currently, we have been paying rent since March 2022, and it's becoming a huge burden on my savings since we cannot be funded by a bank and costing us almost 1.5 million dollars to start up this venture. We submitted our conversion application months ago and were told we needed an LPA to complete our application. We have handed in the Labor Peace Agreement. If the CRC plans to do this all by ranking who gets a license, and there are over 350 application conversions to annual approval and only 15 applicants are getting approved monthly, this could sink us being a small family-owned company. We would pay rent and employees over 1 million dollars before getting started. Many of the bigger chains, such as Cura Leaf, Columbia Care, and Cookies, who have plenty of working capital to survive this onslaught, our getting these licenses before some of the smaller businesses. As small business owners, we desperately need the CRC to approve our license, please help. These are massive amounts of dollars for individuals to spend, and we are a small family-owned business here to join the community and bring tax dollars, as well as jobs and health care to our neighbors. I haven't had any communication from my investigator in months and have been patiently waiting for this day (again for months) only to have my business pulled with no warning, and for no reason. This is very concerning to me! If there were questions I should have been asked or had time to cure whatever your concerns were.....not be singularly pulled off publicly.</p>

7/18/2023	Lonnie Affrime	<p>To the Commissioners of the CRC: I am the CEO of Voltaire NJ Inc., a certified WMBE and small New Jersey business that applied to convert our conditional Class 5 retail license into an annual license (Reference Code #2641). We recognize that the CRC has many responsibilities and have genuinely tried to be patient throughout this process. However, please keep in mind: 1) our conversion paperwork was submitted back in January; 2) we are supposed to be at one of the highest priority levels; 3) since applying, we have never received a cure letter; 4) our CRC investigator (who, for the record, was exceedingly kind, prompt, and professional) completed their investigation back in May; and 5) other than those communications with our investigator, we have received no communication from the CRC since our submission. According to N.J.A.C. 17:30-7.9(c), the CRC is supposed to make a determination on an annual license application "not more than 90 days after the receipt of a complete annual license application". However, it has now been six (6) months (double the allotted timeframe). Due to these delays, not only are we losing out on any revenue throughout the entire summer (which tends to be the busiest time of the year), but we must also continue to pay thousands in carrying costs each month. And due to our limited funding from family and friends, we have had to go to extraordinary lengths just to keep the lease current on our facility. Personally, I haven't received a paycheck in months to ensure that our employees can still get paid enough to survive. So I hope you can understand our frustration upon realizing that our Company was not listed on the agenda for the July 18th CRC meeting. Accordingly, if the CRC does not meet in August, we will not be able to receive a determination from the CRC until at least eight (8) months after our submission. Over the past few months, we have contacted the CRC 5+ times to explain our situation and kindly request some sort of feedback, but each time we received the same curt response: "Your application is in active review. Once a decision regarding it has been reached you will be notified. Thank you." Nevertheless, we have continued waiting patiently out of respect for the CRC and its laudable mission and numerous responsibilities. However, our landlord, township, and investors have (understandably) grown increasingly impatient as the months have gone by without any new information, and we will need to begin taking drastic action soon if we don't receive our license (or at least some sort of substantive response). We believe in the CRC's mission, and we want nothing more than the opportunity to work in partnership with the CRC to enact that mission. However, since we</p>

		<p>began this application process over a year ago (February of 2022), I hope you can also appreciate the stress that I am under, working 90+ hours a week to keep our business afloat while not getting paid and still having no idea when we will be able to open despite already having spent \$500k+ from family and friends who are not wealthy and are betting their savings on our success. All of that being said, despite our frustrations, to be clear, we genuinely do not wish to be difficult, nor do we wish to add any more burdens onto the CRC. As such, we respectfully request the following: 1) Please schedule a CRC meeting in August so that companies on the brink do not have to wait until September to receive a determination. 2) Please provide a public timeline on the CRC website that includes an estimated wait time for each application type (assuming no cure letters are required) and is updated regularly (as appropriate) so that businesses can plan accordingly. 3) Using the CRC portal, please provide applicants with updates on the status/stage of their applications so that companies have some idea of where they are in the application process and are not completely in the dark.
