

# **MEMORANDUM**

Background: On July 17, 2023, Tawfic Helou, Chief Operating Officer of Treehouse Ventures, LLC submitted a request along with the amended Certificate of Formation issued by the Division of Revenue and Enterprise Services validated on July 13, 2023, evidencing their change of name from Treehouse Ventures LLC to Doobiez LLC. This is a full name change and not an amendment to utilize a "doing business as".

Treehouse Ventures, LLC was awarded an Annual License by the Board of Commissioners during its June 1, 2023, public meeting.

On July 25, 2023, Damon Pennington of AACCTPro, LLC submitted a request along with the amended Certificate of Formation issued by the Division of Revenue and Enterprise Services validated on June 27, 2023, evidencing their change of name from AACCTPro, LLC to The Greenhouse Lifestyle of New Jersey LLC. This is a full name change and not an amendment to utilize a "doing business as".

AACCTPro, LLC was awarded an Annual License by the Board of Commissioners during its June 21, 2023, public meeting.

On August 1, 2023, Tara Tucker, President of Liberty Flower Company, submitted a request along with the amended Certificate of Formation issued by the Division of Revenue and Enterprise Services validated on July 31, 2023, evidencing their change of name from Liberty Flower Company to The Public Garden Inc. This is a full name change and not an amendment to utilize a "doing business as".

Liberty Flower Company was awarded an Annual License by the Board of Commissioners during its July 18, 2023, public meeting.



On July 10, 2023, Matthew Miller, Attorney for Strictly CBD LLC submitted a request along with the amended Certificate of Formation issued by the Division of Revenue and Enterprise Services validated on July 7, 2023, evidencing their change of name from Strictly CBD LLC to 1634 Funk LLC. This is a full name change and not an amendment to utilize a "doing business as".

Strictly CBD LLC was awarded an Annual License by the Board of Commissioners during its June 1, 2023, public meeting.

On August 9, 2023, Lisa Gora, Attorney for Garden State Born LLC submitted a request along with the amended Certificate of Formation issued by the Division of Revenue and Enterprise Services validated on August 8, 2023, evidencing their name change from Garden State Born LLC to Garden State Exotix LLC. This is a full name change and not an amendment to utilize a "doing business as".

Garden State Born LLC was awarded Conditional licenses by the Board of Commissioners during the September 9, 2022, meeting (Manufacturer) and the December 2, 2022, meeting (Cultivator).

**Authority:** Adult Use cannabis business applicants and licensees are subject to the Personal Use Cannabis Rules set forth in N.J.A.C. 17:30. To establish a consistent process for applicants and licensees to request changes to their application, they have been informed that they must follow N.J.A.C. 17:30-9.2 which is the designated subchapter for "Changes to license applicant or license holder; approval and notice; provisional approval".

# 17:30-9.2 Changes to license applicant or license holder; approval and notice; provisional approval

(a) Cannabis business license holders shall submit an application for an amended license, along with the applicable fee, if any, pursuant to N.J.A.C. 17:30–7.17, for the following material changes, a change:

1. In ownership, which shall include:

i. Addition or removal of owners or passive investors;

*ii.* Change in license holder entity structure, including any related mergers, acquisitions, or creation of new related entities;

*iii. Change in ownership structure or ownership interest that results in a change of owner, pursuant to N.J.A.C. 17:30–9.3; and* 



iv. Any other changes to the ownership and financial information provided to the Commission pursuant to N.J.A.C. 17:30–7.10 and 7.13;

2. Of management services contractor and the terms of any management services agreement; pursuant to N.J.A.C. 17:30–6.9;

3. Of financial source and the terms of a financial source agreement (FSA) pursuant to N.J.A.C. 17:30–6.10;

4. Of location;

5. Of modification of capacity, physical plant, or premises; or

6. Of name of the cannabis business.

(b) Failure to seek approval for such material changes pursuant to (a) above may result in sanctions upon the license holder pursuant to N.J.A.C. 17:30–17, including civil penalties, or suspension or revocation of any license issued to the license holder.


