RESOLUTION 2023-162
APPROVAL OF APPLICATIONS TO AMEND A PERMIT OR LICENSE TO CHANGE
THE BUSINESS NAME OF A REGULATED ENTITY

WHEREAS, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act,” (“the Act”) authorizes a process for receipt of applications and issuance of permits to operate Alternative Treatment Centers (“ATCs”) in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.8 for amendments to an Alternative Treatment Center permit, including changes of the ATC’s name; and

WHEREAS, the two (2) Alternative Treatment Centers, listed below, have requested changes to each of their respective business names; and

WHEREAS, the two (2) Alternative Treatment Centers have each followed the requirements set forth at N.J.A.C. 17:30A-7.8; and

WHEREAS, each of the two (2) Alternative Treatment Centers have followed the requirements set forth at N.J.A.C. 17:30A-7.1(b)(2) and have submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name; and

WHEREAS, the Commission is charged with implementing the provisions of P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to an issued adult-use cannabis license or award, including changes of the business’s name; and

WHEREAS, five (5) adult-use cannabis annual license awardees listed below have requested changes to each of their respective business names; and

WHEREAS, the five (5) annual license awardees have each followed the requirements set forth at N.J.A.C. 17:30-9.2; and

WHEREAS, each of these license awardees have submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C. 17:30A-7.9, N.J.A.C. 17:30A-7.1(b)(2), and N.J.A.C. 17:30-9.2, the following Alternative Treatment Centers and adult-use cannabis annual license awardees are **APPROVED** to change their business names as proposed in their submission to the Commission:
