BACKGROUND

On August 19, 2021, the Cannabis Regulatory Commission (herein referenced as "Commission" or "CRC") adopted rules pursuant to P.L. 2021, C.16 which established the licensure process for cannabis businesses and testing laboratories. N.J.A.C. 17:30-6 through 7 outlines the application process and requirements for both conditional license applicants and annual license applicants.

Upon accepting this provisional award, the entity is required to pay any application approval fees required pursuant to N.J.A.C. 17:30-7.17. At this time, the listed awardees have failed to meet the provision and it is staff's recommendation that the prior award be rescinded/denied.

This memo outlines the process and recommendations for the denial of 17 applications for conditional licenses that have not paid their license approval fees.

PAYMENT PROCESS OVERVIEW

After recommendation to the CRC Board for approval of licensure, applicants are required to pay their invoices in the licensing portal which includes a license approval fee for conditional licenses. If that fee is unpaid, the delinquent payment process includes the following steps:

- 1. 30 days to pay license approval fee invoice noted in Final Agency Decision letter.
- 2. If unpaid after 30 days, issue final 30-day notice to pay invoice.
- 3. If unpaid after 60 total days, issue notice of denial recommendation.

RECOMMENDATION AND JUSTIFICATION

It is recommended that the conditional applications listed below be presented to the Board of Commissioners for the New Jersey Cannabis Regulatory Commission for denial. The below-listed applicants have not paid the requisite approval fees and have therefore failed to satisfy the regulatory requirements and terms of the Final Agency Decision letter.

RECOMMENDATION SUMMARY

The 17 conditional applications listed above have been deemed non-compliant with their payment requirements. The applicants have not paid the required fees after multiple notices from CRC staff. Therefore, CRC staff recommend the CRC Board deny these applications for licenses.

Notably, these denials for failure to pay the required fees do not preclude an applicant from reapplying for a cannabis business license.
