**SUBJECT:** Medicinal Permit Renewals for the 2024 Calendar Year

### BACKGROUND:

Medicinal permits issued to Alternative Treatment Centers to operate in the State of New Jersey expire on the calendar year (December 31, 2023, for the 2023 permit term). During the permit cycle, it is the responsibility of each Alternative Treatment Center to immediately notify the New Jersey Cannabis Regulatory Commission of any significant changes impacting or affecting the Alternative Treatment Center's organizational structure and business practices. Any significant changes that have not been provided to the Commission during the permit term are required to be identified in the renewal submissions for each Alternative Treatment Center.

On Tuesday, September 5, 2023, a notice was sent to all Alternative Treatment Centers that had, at that time, been permitted for a full year or more, to notify of the obligation to submit a renewal application with all required documentation and the requisite fees. All applicants for permit renewal were directed to submit their documentation no later than the close of business on Monday, October 2, 2023, via electronic mail to the Director for the Office of Compliance and Investigations. Of the Alternative Treatment Centers permitted and operational in the State of New Jersey, fifteen (15) were operational for at least one year as of September 5, 2023. Of those fifteen (15), all timely submitted their renewal applications. The fee for renewal for these Alternative Treatment Centers is \$20,000.00.

On Thursday, October 12, 2023, a notice was sent to all Alternative Treatment Centers that had, at that time, been permitted for less than one year, to notify of the obligation to submit a certification that the Alternative Treatment Center will continue prioritizing service to the medical patient population and will remain in compliance with all Final Agency Decision post-award conditions in order to have their permit extended for the 2024 calendar year. All applicants for permit extension were directed to submit their documentation no later than the close of business on Monday, November 13, 2023, via electronic mail to the Director for the Office of Compliance and Investigations. Of the Alternative Treatment Centers permitted and operational in the State of New Jersey, seventeen (17) were operational for less than one year as of October 12, 2023. Of those seventeen (17), all seventeen (17) timely submitted their renewal extension request. As these entities have not been operational for a full year since paying the initial application fee, and



consistent with past practice, no fee is required for extension of the initial permit term through the end of 2024.

**AUTHORITY:**

**N.J. Admin. Code § 17:30A-7.7**

(a) 60 days prior to the expiration of an ATC permit, an ATC that seeks to renew the permit shall submit to the permitting authority an application for renewal of the permit with all required documentation and the required fees pursuant to N.J.A.C. 17:30A-7.10.

1. An ATC shall update and ensure the correctness of all information submitted in previous applications for a permit or otherwise on file with the Commission.

2. Failure to provide correct and current up-to-date information is grounds for denial of application for renewal of the permit.

(b) The permit period for an alternative treatment center shall be from January 1st (or the date of approval of the application, if later) through December 31st of a given year.

(c) The Commission may deny the application for renewal of the permit if the applicant is noncompliant with applicable local rules, ordinances, and/or zoning requirements, or if the Commission determines that the facility is in violation of the Act or this chapter.

(d) The Commission may issue and/or renew a permit subject to conditions set forth in this chapter.

**N.J. Admin. Code § 17:30A-7.10**

(a) The following fees apply:

1. The annual fee for the review of a permit renewal application for an alternative treatment center is \$20,000;

2. The fee to apply for a change of location of the alternative treatment center is \$10,000;

3. The fee to apply for a change of capacity or any physical modification or addition to the facility is \$2,000; and

4. The fee to apply for the transfer of ownership of a permit is \$20,000.

(b) Fees shall be paid by certified check, money order, or any other form of payment approved by the Commission, and made payable to the “Treasurer, State of New Jersey.”
