



Majority Ownership Awardees with Prior Marijuana Conviction









Permitting & Licensing Committee Report



43 total extensions granted in March.

- 35 conditional extensions
- 2 2019 RFA extensions; and
- 6 AU extensions to operate

Permitting & Licensing Committee Report

- Out of 44 2019 RFA awardees, 21 awardees are still waiting to become operational.
- Awardees are facing significant construction build-out and local permitting delays to become operational.
- Committee's recommendation: Amend the 2019 RFA to remove operational deadlines and amend the 2019 RFA Final Agency Decisions accordingly.



Permitting & Licensing Committee Report

- 394 awardees that have yet to request an onsite assessment.
- Under N.J.A.C. 17:30-7.14(f), awardees must request a final onsite assessment within *365 days from the date of award*.
- External factors: Facilities are not yet built out or remain under construction, and delays with local approvals.
- Committee's recommendation: Waive N.J.A.C. 17:30-7.14(f) to eliminate the 365-day deadline by which a cannabis business must request a final onsite assessment.



Permitting & Licensing Committee Report

The Committee will solicit feedback on the application and licensing processes.

The Committee will convene a public hearing this spring to:

- Give the public an opportunity to weigh in on the current licensing process
- Understand what's working and what can be improved
- Hear ideas to make processes more efficient

Packaging Requirements

Packaging Requirements

- **Serving Size**

Each *package* of finished cannabis or cannabis product, dependent on form shall contain:

Product Type	Active THC	Usable Cannabis	
Inhalable		¼ ounce or less*	
Ingestible	100 mg or less		
Cannabis	10 mg or less*		
*or equivalent weight dependent on form;			

Each single serving of a cannabis product shall have a cannabinoid concentration that is within 90% -110% of the specified milligram serving size claimed for that cannabis product.



Packaging Requirements

- **Child Resistant Packaging**
- Designed or constructed to be significantly difficult for children under five years of age to open and not difficult for adults to use properly.
 - Be fully enclosed, opaque, of a single color, and light resistant;
 - Able to be resealed in a child-resistant manner unless the package contains a single serving cannabis item; and
 - For ingestible products in liquid form with multiple serving units, the container must have a resealing cap or closure

Labeling Requirements



- False/Misleading Information
- Statement, Illustration, Image, Cartoon, Color Scheme, Graphic, or Feature that might make the cannabis item or package attractive to children.

Clear Space

The NJ Universal Symbol must always have a clear area surrounding it, free from any other element.

To define this area around the symbol, measure the height of the symbol and use a quarter of this measure to create the boundary of clear space.

PACKAGING & LABELING: .125"
PRODUCT IMPRINT: .0625"



Background

The icons should be placed on a white or light-colored background. The interior of the icon must remain white as shown. If it must go on a dark background, use the correct symbol for dark backgrounds.

Restrictions

- Do not re-create or modify the icons in any manner.
- Do not stretch or distort the icons.
- Do not use the icons smaller than the minimum size.
- Do not change the icon colors (Note: Coloring is not required for on-product markings.)
- Do not use the icons on a dark background.

- A summary of the written report detailing the results of the laboratory testing, including, but not limited to:
 - Potency of all major cannabinoids
 - A list of major terpenoids detected



Consumer and Product Information

- **Serving Size**

- Single Serving

- Each single serving of a cannabis product contained in a multiple-serving package shall be marked, stamped or otherwise imprinted with the universal symbol issued by the Commission that indicates that the single serving is a cannabis product

- Multiple Servings

- Packaging for cannabis products sold or displayed for consumers in multiple servings shall include the following statement on the exterior of the package **in a printed font that is no smaller than (10) ten-point Times New Roman, Helvetica or Arial, including capitalization: “INCLUDES MULTIPLE SERVINGS.”**

Consideration of Rule Waivers and Advisory Notices on Regulatory Policy



Consideration of Rule Waivers and Advisory Notices on Regulatory Policy (N.J.A.C. 17:30-7.14)

- Proposed elimination of 365-day operational deadline for final onsite assessments for cannabis businesses
- Waiver will:
 - Ensure more efficient licensing process for applicants
 - Benefit cannabis businesses that may be at risk for losing their cannabis business licenses due to delays caused by external factors
 - Not impede on public health safety or welfare
 - Allows businesses to take needed time necessary to become operational



Consideration of Rule Waivers and Advisory Notices on Regulatory Policy (N.J.A.C. 17:30-7.14)

- Waiver is subject to following terms and conditions:
 - Only applies to annual cannabis business license applicants
 - Eliminates 356-day deadline by which a cannabis business must request a final onsite assessment
 - Awardees must remain in communication with field monitor regarding status of construction and preparation
 - The Committee will periodically review status of cannabis business license awardees to ensure communication with field monitor
