Licensing Update – Total Licenses Approved

Edibles Rule Waiver

- On September 8, 2023, the Commission waived N.J.A.C. 17:30A-10.7(e), 17:30-11.5(c)(2), and –11.6(b) to allow the production and dispensing of additional edible forms.
- The Commission allowed the manufacturing and dispensing of the following forms:
 - Dried form
 - Topical formulations
 - Oil formulations
 - Syrups or single-serve beverages
 - Pills, capsules, or tablets
 - Oral suspensions
 - Non-TCS food items, such as chocolates, gummies, baked goods, butters, jams, and jellies, such that the product does not require time or temperature control to limit pathogenic microorganism growth or toxin formation.

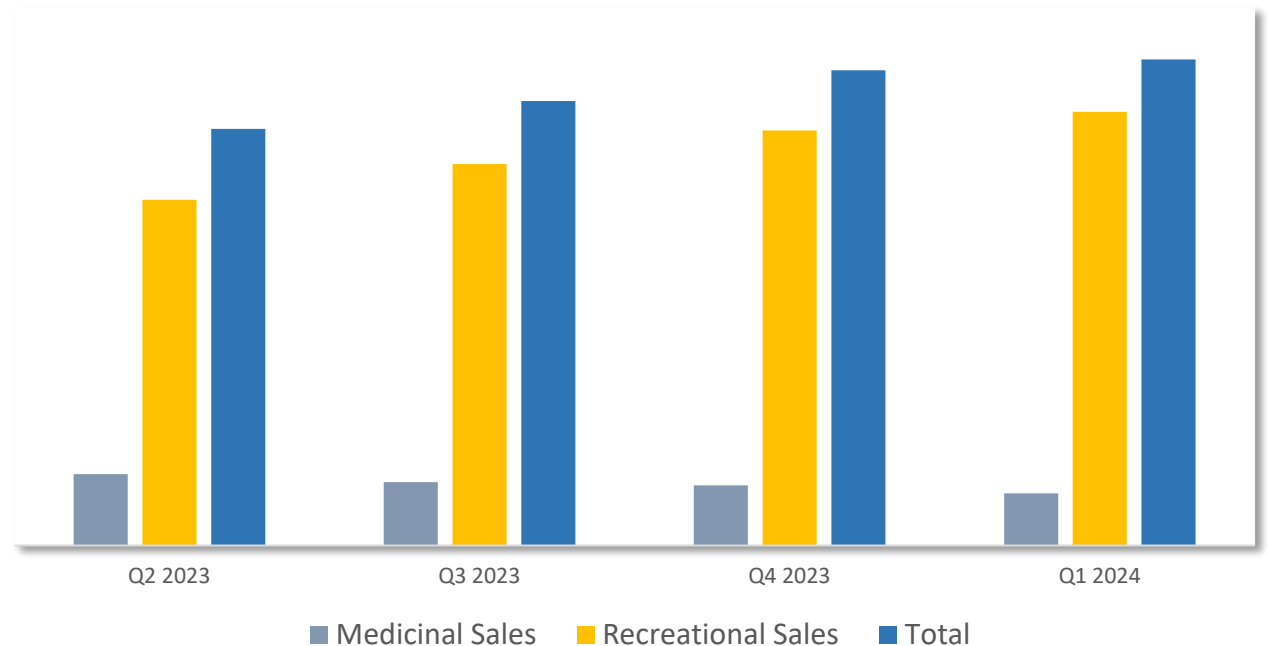

NJ Cannabis Sales (Last 4 Quarters)

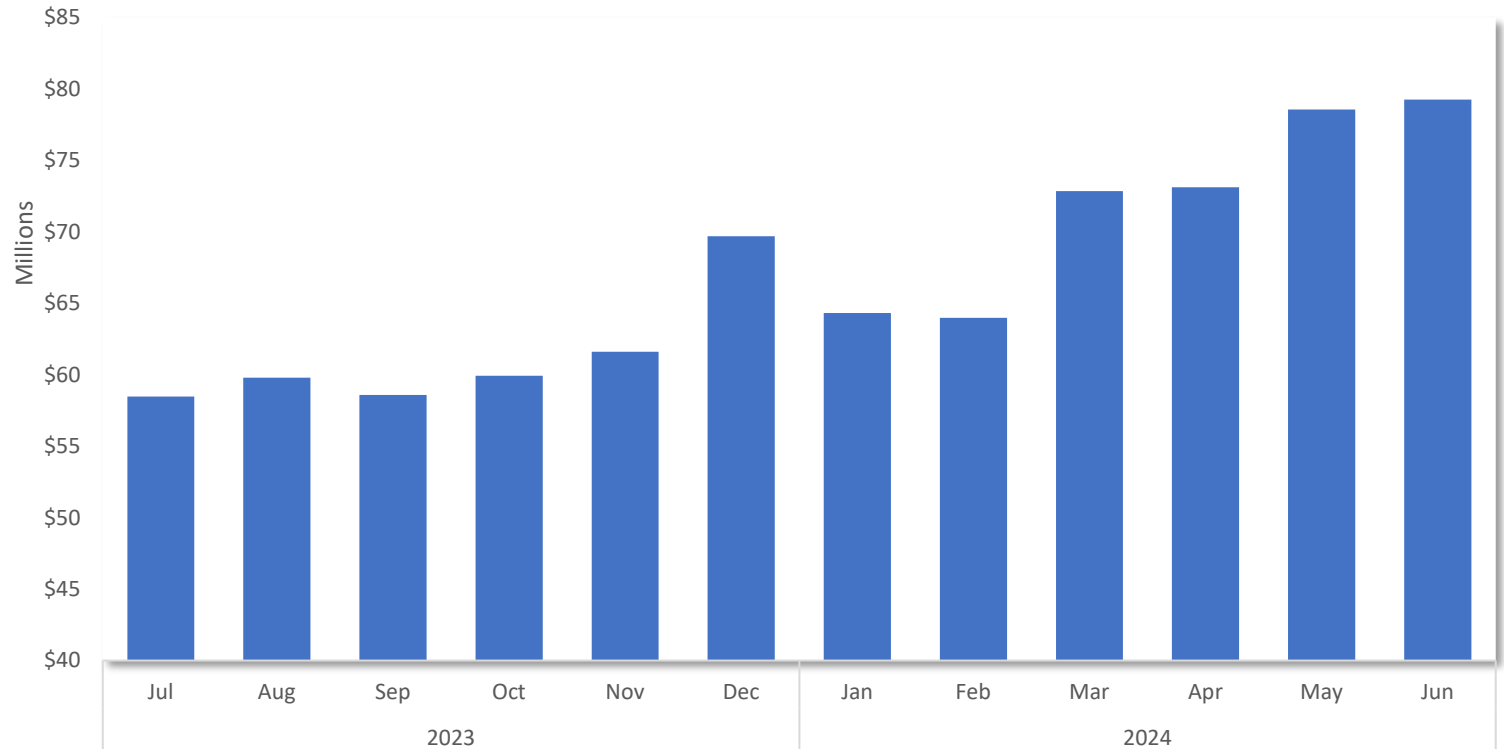

NJ Adult Use Cannabis Sales (Last 12 Months)

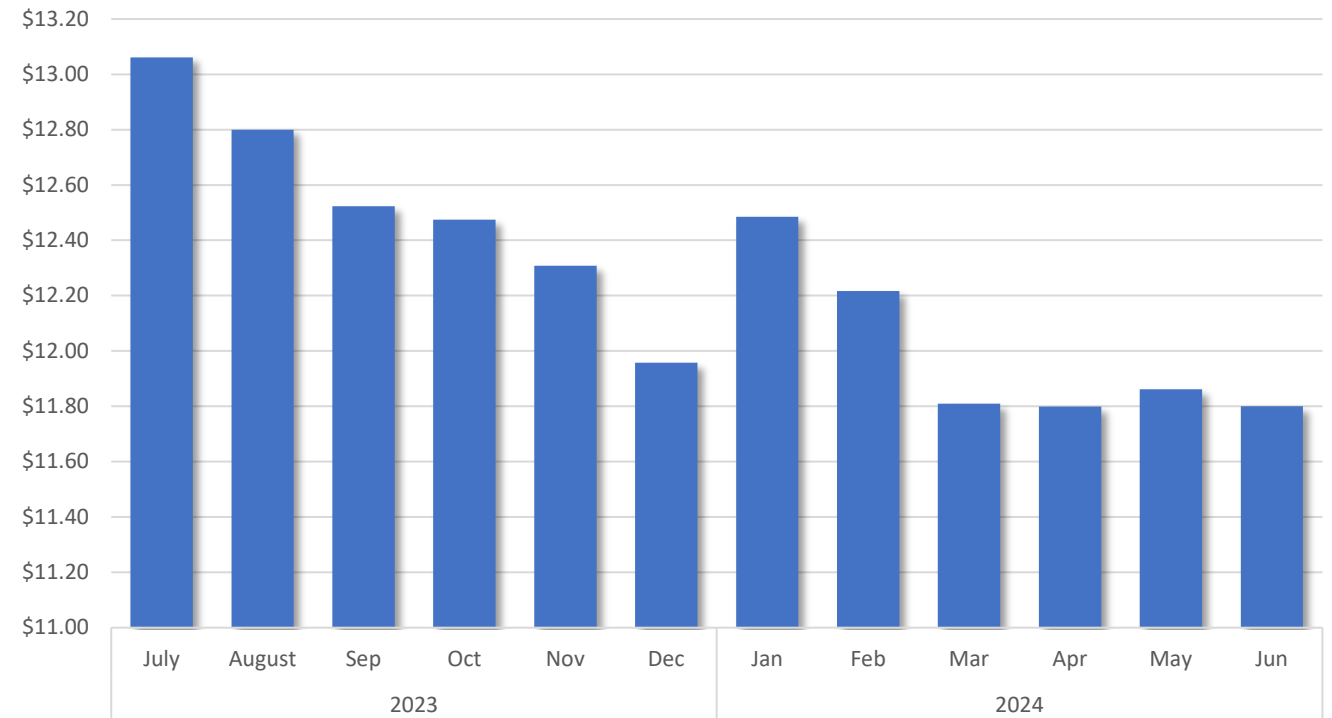

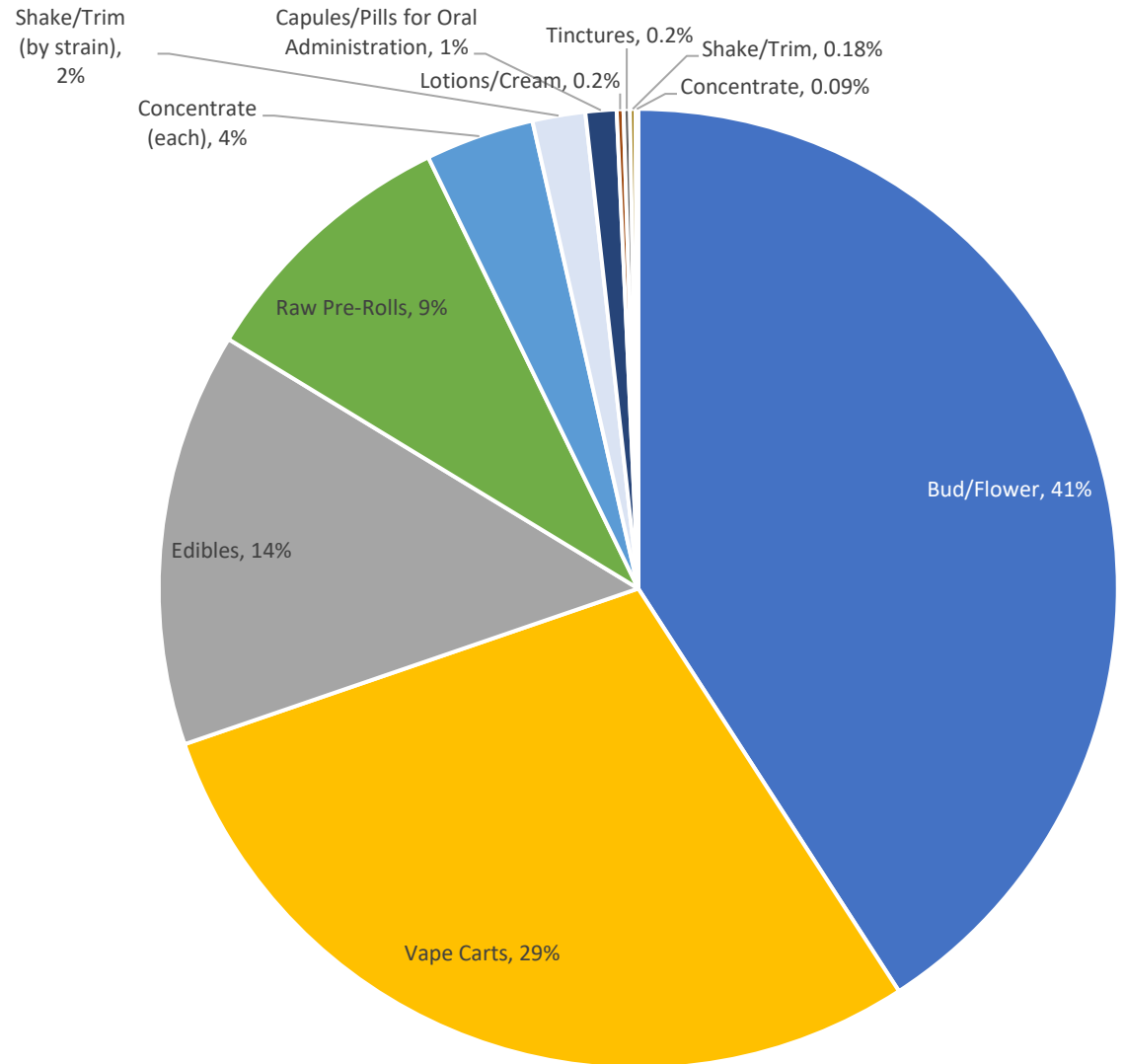
Adult Use Price Per Gram (Last 12 Months)





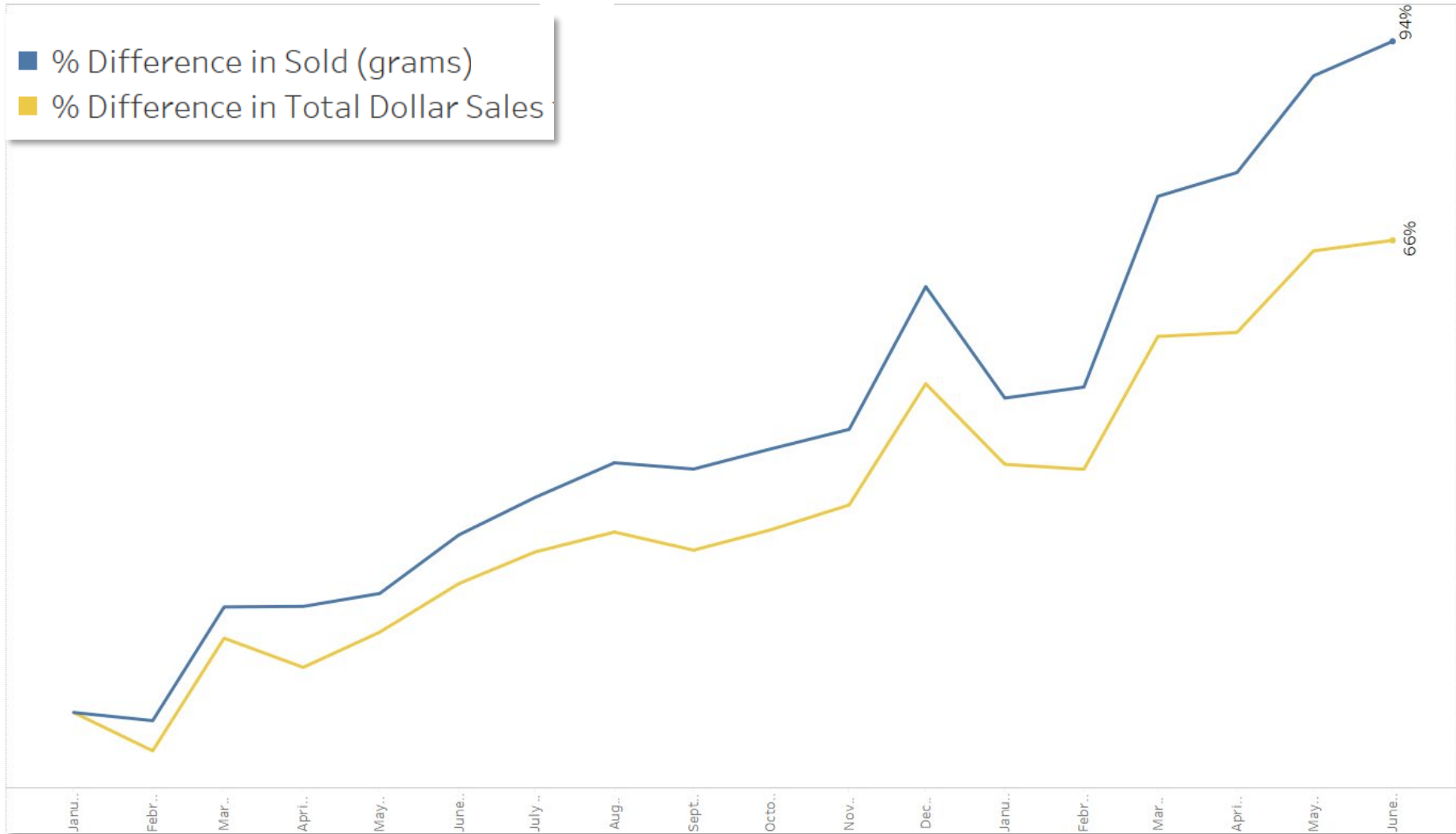

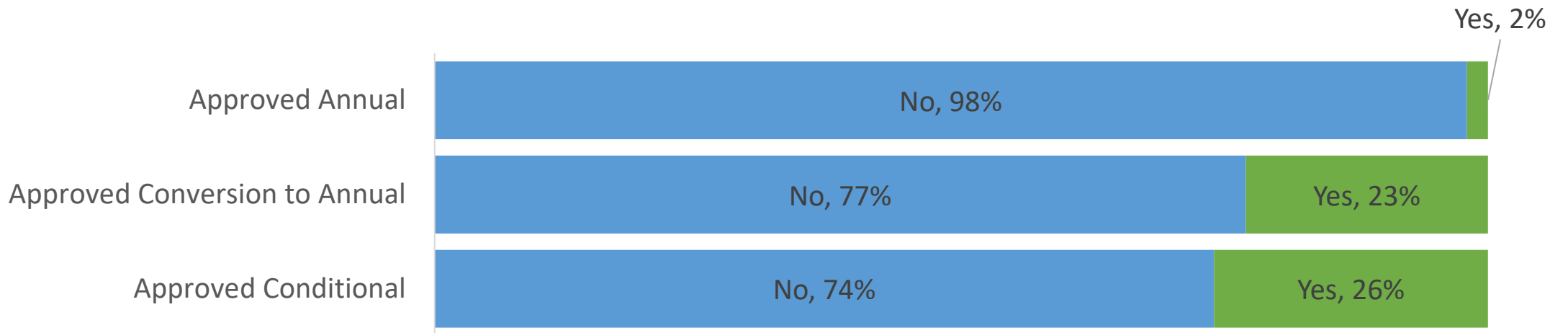

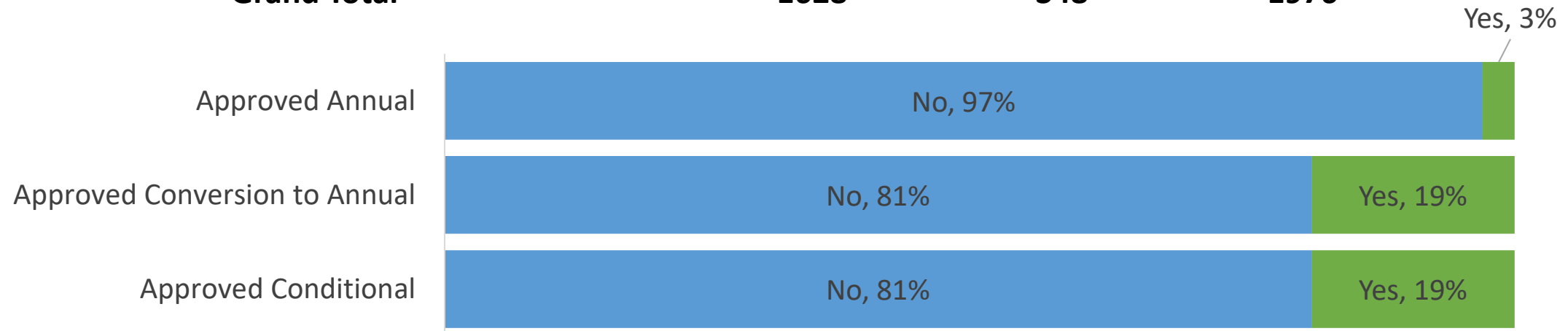

Majority Ownership Awardees with Prior Marijuana Conviction

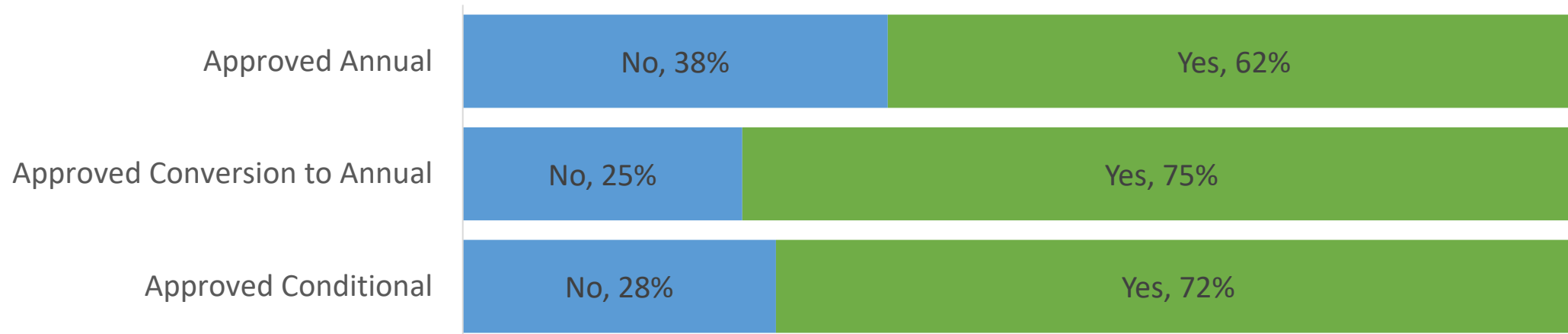

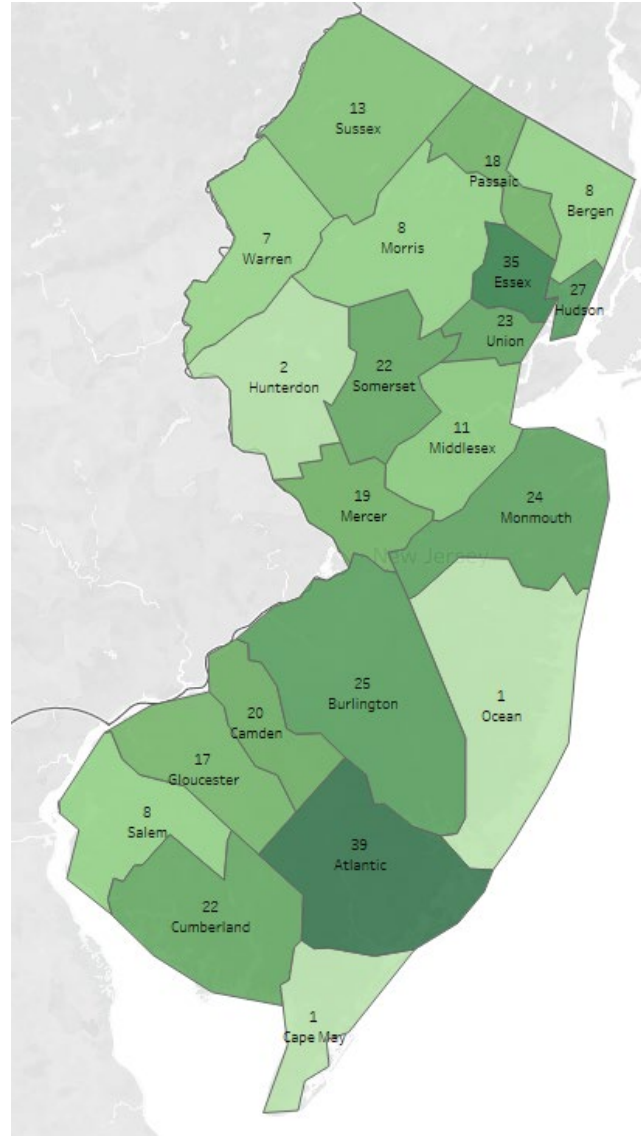

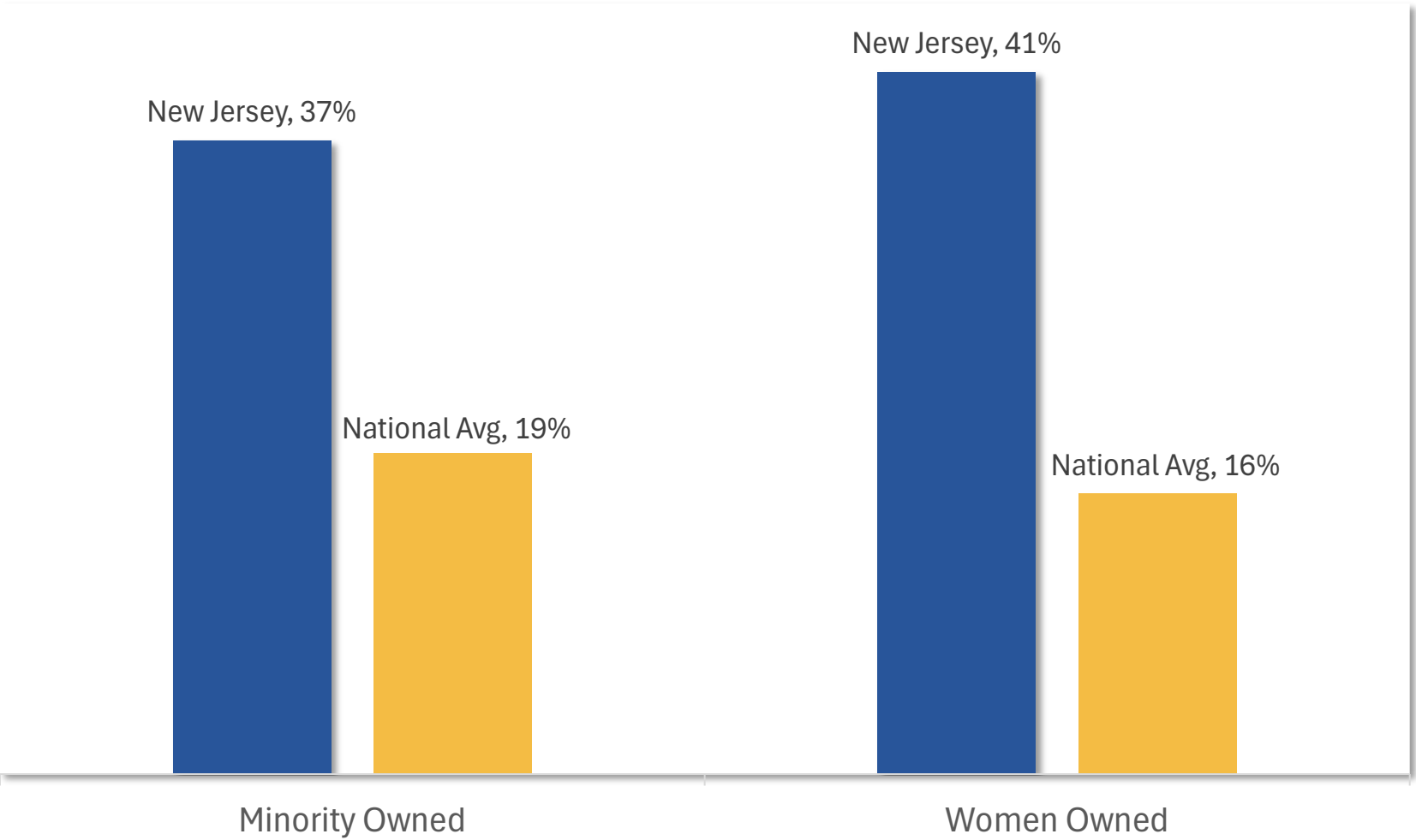

Clinical Registrants Rule Adoption (N.J.S.A. 24:6I-7.3)

- 60-day comment period ended on October 6, 2023
- Proposed rules establish a process for Clinical Registrant applications
- Allows ATC permit holders to engage in clinical research
- Must be associated with a regional academic medical center to conduct research, cultivate, manufacture, and dispense medicinal cannabis and products
- The notice will be filed with the Office of Administrative Law
