**RESOLUTION 2024-299**  
**APPROVAL OF ADDENDUM TO THE NOTICE OF APPLICATION ACCEPTANCE**  
**FOR A CANNABIS CONSUMPTION AREA ENDORSEMENT**

**WHEREAS**, pursuant to N.J.S.A. 24:6I-31 through -59 and N.J.A.C. 17:30, the New Jersey Cannabis Regulatory Commission (“Commission” or “NJ-CRC”) is responsible for accepting, reviewing, and making determinations on applications for personal-use cannabis business licenses; and

**WHEREAS**, pursuant to N.J.A.C. 17:30-6.1(b), the Commission shall accept new license applications and issue additional licenses, as it deems necessary to meet market demands; and

**WHEREAS**, pursuant to N.J.A.C. 17:30-6.1(c)(2), the Commission shall provide notice of the initial acceptance of license applications in the New Jersey Register, on the Commission website, to the Commission email list, and at a Commission public meeting; and

**WHEREAS**, the Commission adopted a Notice of Application Acceptance concerning applications for personal-use cannabis business licenses on November 9, 2021, via Resolution 2021-17; and

**WHEREAS**, the attached Addendum to the Notice of Application Acceptance shall serve as public notice and provide guidance to Class 5 Retailer license holders on the process and procedures for applying for a cannabis consumption area endorsement; and

**WHEREAS**, the Commissioners and NJ-CRC staff have reviewed the Notice of Application Acceptance Addendum and have determined that it meets the requirements of N.J.S.A. 24:6I-31 through -59 and N.J.A.C. 17:30; and

**WHEREAS**, the Notice of Application Acceptance Addendum establishes that the Commission reserves the right to update the Notice, and that any update will be announced at a public meeting, posted on the NJ-CRC website, published in the New Jersey Register, and sent to the NJ-CRC’s e-mail list; and

**NOW, THEREFORE, BE IT RESOLVED** by the New Jersey Cannabis Regulatory Commission that the attached Notice of Application Acceptance Addendum to accept, review, and score applications for a cannabis consumption area endorsement set forth therein is hereby approved.


