RESOLUTION 2024-<u>303</u> APPROVAL OF RENEWAL APPLICATION FOR MEDICINAL CANNABIS PERMITS FOR ALTERNATIVE TREATMENT CENTERS

WHEREAS, P.L.2019, c.153, "Jake Honig Compassionate Use Medical Cannabis Act," ("the Act") authorizes a process for receipt of applications and issuance of permits to operate Alternative Treatment Centers ("ATCs") in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health ("the Department"), and now vests in the New Jersey Cannabis Regulatory Commission ("the Commission") pursuant to P.L. 2019, c.153; and

WHEREAS, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.6 and N.J.A.C. 17:30A-7.7 for renewals of ATC permits; and

WHEREAS, pursuant to N.J.A.C. 17:30A-7.7(b), "[t]he permit period for an [ATC] shall be from January 1st (or the date of approval of the application, if later) through December 31st of a given year"; and

WHEREAS, pursuant to N.J.A.C. 17:30A-7.6, an ATC must renew its permit at the end of each year when the ATC has been in operation for a minimum of one (1) year; and

WHEREAS, an ATC that has been in operation for one (1) year or longer is required to submit a full renewal application with fees, in accordance with N.J.A.C. 17:30A-7.7 and N.J.A.C. 17:30A-7.10; and

WHEREAS, pursuant to N.J.A.C. 17:30A-7.7(a), ATCs are required to submit their renewal application 60-days prior to the expiration of the permit; and

WHEREAS, the Commission reviews the renewal application and verifies that there are no material changes made that would otherwise require approval under N.J.A.C. 17:30A-7.8, and that the ATC is in compliance with the regulations governing the management, operation, and financing of the ATC; and

WHEREAS, the Commission reviews the attestation to confirm that the ATC will continue

to prioritize service to the medicinal patient population and will continue to remain in compliance with post-award conditions set forth in their Final Agency Decision; and

WHEREAS, eighty-seven (87) ATCs who have been operational for one (1) year or more and have submitted a full renewal application along with the requisite fees to renew their medicinal permits for the 2025 permit term; and

WHEREAS, the Commission has reviewed the full renewal applications for ATCs who have been operational for more than one (1) year for completeness and accuracy and for material factors that could impact the renewal or extension of the permit; and

WHEREAS, the Commission has determined that the permit renewals submitted by the eighty-seven (87) ATCs for the 2025 permit term are complete and accurate and in compliance with the requirements of the Commission;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C. 17:30A-7.7, the following ATCs have satisfied the requirements set forth under the law and regulations and the Commission has determined to renew the entity's medicinal cannabis permit as set forth below:
