APPROVAL OF APPLICATION ALLOWING MODIFICATION OF CAPACITY, PHYSICAL
PLANT, PREMISES, OR ADMINISTRATIVE OFFICE

Dear Kelly Gatto:

The New Jersey Cannabis Regulatory Commission ("NJ-CRC" or "Commission") has received and reviewed Brute's Roots LLC's application requesting approval of a modification of capacity, physical plant, premises, or administrative office. Specifically, Brute's Roots LLC, an expanded Alternative Treatment Center ("expanded ATC"), has requested approval of a capacity modification to expand its adult-use cannabis canopy size from Tier I to Tier VI. Your application has been approved, pending payment of the requisite fee of **\$2,000** and subject to passing a final onsite assessment.

Pursuant to N.J.A.C. 17:30-9.2(a)(5), a cannabis business shall submit to the NJ-CRC an application for an amended license prior to any modification of a cannabis business's capacity, physical plant, premises, or administrative office. Pursuant to N.J.A.C. 17:30-7.17(j), the fee to apply for a change or modification of a cannabis business's capacity or physical plant is \$2,000. Brute's Roots LLC was approved as a vertically integrated ATC pursuant to the New Jersey Department of Health's 2019 Request for Applications and is authorized to cultivate medical cannabis within a maximum canopy size of 30,000 square feet. Accordingly, nothing herein shall be construed to authorize an increase in the business's authorized maximum medical cannabis canopy.
