RESOLUTION 2025-3-18-04
RENEWAL OF ADULT-USE CANNABIS BUSINESS LICENSES

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, pursuant to N.J.S.A. 24:6I-35(a)(1) of the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, N.J.S.A. 24:6I-31 et seq., (“the Act”), the Commission shall adopt rules and regulations, which include “[p]rocedures for the application, issuance, denial, renewal, suspension, and revocation of a license or conditional license to operate as a cannabis establishment, distributor, or delivery service”; and

WHEREAS, the Commission approved and issued a license to the following expanded Alternative Treatment Centers (“ATC”):

WHEREAS, pursuant to N.J.A.C. 17:30-9.4(m)(3), in order to renew its cannabis business license after its first year of operations pursuant to N.J.A.C. 17:30-7.16, an expanded ATC shall:

- i. Certify to the Commission as to the continued material accuracy of the expanded ATC’s previously approved ATC license application and its compliance with the provisions of the Act regarding its operations concerning cannabis or cannabis items; and
- ii. Submit a new written approval from the municipality in which the expanded ATC is located, approving the continued operations as a cannabis business; and

WHEREAS, the expanded ATCs listed above are currently in their first year of adult-use cannabis operations; and

WHEREAS, the expanded ATCs listed above provided a certification to the Commission as to the continued material accuracy of the expanded ATC’s previously approved license application, and the Commission has determined that the expanded ATC is currently in compliance with the Act and the governing regulations regarding its operations concerning cannabis items; and

WHEREAS, the expanded ATCs listed above submitted a new written approval from each municipality in which the expanded ATC is located, approving the continued operations as a cannabis business; and

WHEREAS, the Commission has determined that a complete and accurate renewal application was submitted pursuant to N.J.A.C. 17:30-9.4(m)(3) for the license listed above; and

WHEREAS, the expanded ATCs listed above shall pay the requisite renewal fees pursuant to N.J.A.C. 17:30-7.17, as applicable; and

WHEREAS, the Commission approved and issued licenses to the following adult-use cannabis businesses:


