RESOLUTION 2025-10-01-03
APPROVAL OF APPLICATION TO CHANGE LOCATION: GOT YOUR SIX OF NEW JERSEY LLC

WHEREAS, the New Jersey Cannabis Regulatory Commission (“the Commission”), established pursuant to P.L.2019, c.153, known and cited as the “Jake Honig Compassionate Use Medical Cannabis Act,” is charged with implementing the provisions of that Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

WHEREAS, pursuant to N.J.A.C. 17:30-9.2(a)(4), cannabis business license holders shall submit an application for an amended license, along with any applicable fee pursuant to N.J.A.C. 17:30-7.17, for material changes, including a change in location; and

WHEREAS, cannabis business license holders must satisfy the requirements as set forth in N.J.A.C. 17:30-7.8 and N.J.A.C. 17:30-7.10 regarding the proposed location, including demonstrating zoning approval, site control, and proof of local support; and

WHEREAS, the entity listed below has followed the requirements set forth in the regulations for the amendment to its license; and

WHEREAS, the entity listed below has provided a resolution of support, zoning approval, and has provided evidence of site control;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission the following adult-use cannabis business is **APPROVED** to change its location as proposed in its submission to the Commission, pending payment of the requisite fees for the amendment to its adult-use cannabis license in accordance with N.J.A.C. 17:30-7.17:

Amendments to the adult-use cannabis license shall not be executed until Got Your Six of New Jersey LLC passes a final onsite assessment of the new Princeton facility. Got Your Six of New Jersey LLC shall not conduct any dispensing activities at the new Princeton facility until it receives an amended adult-use license authorizing it to commence such activities.

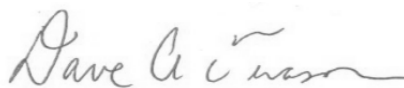
