**RESOLUTION 2025-12-17-04**  
**APPROVAL OF APPLICATION TO MODIFY CAPACITY, PHYSICAL PLANT,**  
**PREMISES, OR ADMINISTRATIVE OFFICE**

**WHEREAS**, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act” (“the Act”) authorizes a process for the receipt of applications and issuances of permits to operate Alternative Treatment Centers (“ATC”) in the state of New Jersey; and

**WHEREAS**, the authority to regulate and enforce activities related to medical cannabis previously vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to the Act; and

**WHEREAS**, the Commission is also charged with implementing the provisions of P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act” (“the CREAMM Act”), which vests in the Commission the authority to regulate and enforce activities related to personal-use cannabis; and

**WHEREAS**, the regulations for medical cannabis provide a process at N.J.A.C. 17:30A-7.8 for amendments to an ATC’s permit, including a change in the ATC’s capacity or modification of or addition to the ATC’s physical plant; and

**WHEREAS**, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to a cannabis business license, including modification of cannabis business’ capacity, physical plant, premises, or administrative office; and

**WHEREAS**, in accordance with Resolution 2022-10, the Executive Director or his designee has been delegated the authority to approve applications for facility modifications pursuant to N.J.A.C. 17:30A-7.8 and N.J.A.C. 17:30-9.2(a)(5) so long as the modification sought would not alter the business’s authorized canopy size or otherwise substantially affect the business’s operations; and

**WHEREAS**, pursuant to N.J.A.C. 17:30A-7.10, the fee to apply for a change in the ATC’s capacity or any physical modification or addition to the facility is \$2,000; and

**WHEREAS**, pursuant to N.J.A.C. 17:30-7.17, the fee to apply for a change or modification of the cannabis business’ capacity or physical plant is \$2,000; and

**WHEREAS**, Atlantic Cultivators LLC (“Atlantic Cultivators”), a Class 1 Cannabis Cultivator, has requested approval of their application to modify their capacity and increase their cultivation canopy tier from indoor Tier I to outdoor Tier VI, which would allow Atlantic Cultivators to grow in a canopy area up to 150,000 square feet; and

**WHEREAS**, Atlantic Cultivators has followed the requirements set forth at N.J.A.C. 17:30-9.2;

**NOW, THEREFORE, BE IT RESOLVED** by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C. 17:30A-7.8 and N.J.A.C. 17:30-9.2, as applicable, concerning modifications of an ATC’s permit or a cannabis business’s license, the following application to modify the business capacity, physical plant, premises, or administrative office is hereby **APPROVED**, pending payment of the requisite fees in accordance with N.J.A.C. 17:30-7.17 and N.J.A.C. 17:30A-7.10 and subject to passing a final onsite assessment:

- *Change in capacity*: Atlantic Cultivators is approved to expand their adult-use cannabis cultivation canopy tier from indoor Tier 1 to outdoor Tier VI, which would allow Atlantic Cultivators to grow in a canopy area up to 150,000 sq. ft.


