RESOLUTION 2026-01-13-05
ADMINISTRATIVE EXTENSION OF
APPLICATIONS FOR RENEWAL OF ADULT-USE CANNABIS BUSINESS LICENSES

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health ("the Department"), and now vests in the New Jersey Cannabis Regulatory Commission ("the Commission") pursuant to P.L. 2019, c.153; and

WHEREAS, pursuant to N.J.S.A. 24:6I-35(a)(1) of the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, N.J.S.A. 24:6I-31 et seq., ("the Act"), the Commission shall adopt rules and regulations, which include "[p]rocedures for the application, issuance, denial, renewal, suspension, and revocation of a license or conditional license to operate as a cannabis establishment, distributor, or delivery service"; and

WHEREAS, the Commission approved and issued licenses to the following adult-use cannabis businesses:

ADULT USE CANNABIS BUSINESS LICENSES:

WHEREAS, adult-use cannabis business license holders are required to submit a renewal application in compliance with N.J.A.C. 17:30-7.16; and

WHEREAS, the licenses of the two (2) adult-use cannabis businesses listed above submitted renewal applications in accordance with N.J.A.C. 17:30-7.16; and

WHEREAS, additional time is required to review the renewal applications of the above listed entities to ensure that they are compliant with N.J.A.C. 17:30-7.16.

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.S.A. 24:6I-35(a)(1), N.J.A.C. 17:30-9.4(m), and N.J.A.C. 17:30-7.16, the following cannabis business licensees are granted a 30-day administrative extension of their license expiration date to allow additional time for the Commission to review their submissions for renewal:


