RESOLUTION 2026-03-31-12
ADMINISTRATIVE EXTENSION OF ADULT-USE CANNABIS BUSINESS LICENSES

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, pursuant to N.J.S.A. 24:6I-35(a)(1) of the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, N.J.S.A. 24:6I-31 et seq., (“the Act”), the Commission shall adopt rules and regulations, which include “[p]rocedures for the application, issuance, denial, renewal, suspension, and revocation of a license or conditional license to operate as a cannabis establishment, distributor, or delivery service”; and

WHEREAS, the Commission approved and issued licenses to the following adult-use cannabis businesses:

Civil Action No. 3:25-cv-16397-MAS-RLS, the Commission hereby grants an administrative extension of the Curaleaf’s personal-use licenses listed below 60 days, by which time the Commission will reassess whether to grant additional administrative extensions or render a final decision on the license renewal:


