RESOLUTION 2026-04-23-01
ELECTION OF VICE CHAIR

WHEREAS, the Jake Honig Compassionate Use Medical Cannabis Act, P.L.2019, c.153, ("the Act") provides that the New Jersey Cannabis Regulatory Commission ("NJ-CRC" or "Commission") shall consist of five members, one of whom shall be designated by a majority of the total authorized members as the chair, and one of whom shall be designated the vice-chair in accordance with the appointment process set forth in N.J.S.A. 24:6I-24(b)(7); and

WHEREAS, N.J.S.A. 24:6I-24(b) requires the Commission members to elect, by a majority of the total authorized membership of the Commission, one of the members who is appointed by the Senate President or Speaker of the General Assembly to serve as vice chair during that member's term; and

WHEREAS, a new vice chair shall be elected upon the expiration of the current vice chair's term, even if that member remains on the Commission until that member's successor is duly appointed and qualified; and

WHEREAS, should the position of vice become vacant for any reason, the Commission must elect a new vice chair; and

WHEREAS, pursuant to the Act, the vice chair shall be empowered to carry out all of the responsibilities of the chair during the chair's absence, disqualification, or inability to serve; and

WHEREAS, Commissioner Ferraro was appointed to the Commission by the Speaker of the General Assembly; and

WHEREAS, a majority of the total members of the Commission was present at the April 23, 2026, Board meeting;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission that, effective immediately, Commission member Jacqueline Ferraro, who was appointed to the Commission by the Speaker of the General Assembly, is hereby elected Vice Chair of the New Jersey Cannabis Regulatory Commission, to serve in such capacity until the

expiration of the member's term.


