RESOLUTION 2026-04-23-04
APPROVAL OF APPLICATION TO CHANGE LOCATION: LUCKY BUDS LLC

WHEREAS, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act” (“the Act”) authorizes a process for the receipt of applications and issuances of permits to operate Alternative Treatment Centers (“ATC”) in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medical cannabis previously vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to the Act; and

WHEREAS, the Commission is also charged with implementing the provisions of P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act” (“the CREAMM Act”), which vests in the Commission the authority to regulate and enforce activities related to personal-use cannabis; and

WHEREAS, pursuant to N.J.A.C. 17:30A-7.8, an ATC shall submit an application for an amended permit, along with any applicable fee pursuant to N.J.A.C. 17:30A-7.10, for material changes, including a change in location; and

WHEREAS, pursuant to N.J.A.C. 17:30-9.2(a)(4), cannabis business license holders shall submit an application for an amended license, along with any applicable fee pursuant to N.J.A.C. 17:30-7.17, for material changes, including a change in location; and

WHEREAS, pursuant to N.J.A.C. 17:30A-7.10, the fee to apply for a change in the ATC’s location is \$10,000; and

WHEREAS, pursuant to N.J.A.C. 17:30-7.17, the fee to apply for a change of the cannabis business’ location is \$10,000 for a standard cannabis business or \$1,000 for a microbusiness; and

WHEREAS, ATC permit holders and cannabis business license holders must satisfy the requirements as set forth in N.J.A.C. 17:30A-7.8, N.J.A.C 17:30-7.8 and N.J.A.C. 17:30-7.10, as applicable, regarding the proposed location, including demonstrating zoning approval, site control, and proof of local support; and

WHEREAS, the entity listed below has followed the requirements set forth in the regulations for the amendment to its license and/or permit; and

WHEREAS, the entity listed below has provided a resolution of support, zoning approval, and

has provided evidence of site control;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission the following adult-use cannabis business and/or ATC is **APPROVED** to change its location as proposed in its submission to the Commission, pending payment of the requisite fees for the amendment to its adult-use cannabis license and/or medical permit in accordance with N.J.A.C. 17:30-7.17 and/or N.J.A.C. 17:30A-7.10:

Amendments to the adult-use cannabis license and/or medical permit shall not be executed until the applicant passes a final onsite assessment of the new facility. The above applicant shall not conduct any cultivation, manufacturing, or dispensing activities at the new facility until it receives an amended adult-use license and/or medical permit authorizing it to commence such activities.


