Consequently, almost all of us lack the benefit of financially privileged upbringing and inheritance. Since most of us lack generational wealth, should most Americans receive payouts? Because the cost of living differs in various locations, a particular net worth represents differing degrees of wealth. Should eligibility depend on where people live?

Those who suffered discrimination centuries ago, no longer live, so they cannot receive payments. Decedents of those victims lack the benefit of generational wealth, but the United States does not guarantee inheritance. Our laws and courts seek to provide opportunity for rich and poor in all groups. No matter how well intentioned, to artificially benefit some people discriminates against others. Is modern day discrimination the remedy to historical discrimination? I think not.

Equity strives to improve the lot of some people, by providing goods and services – a laudable endeavor. Nevertheless, to treat some people differently than others is contrary to the concept of equality. In order to prevent discrimination, the value of goods and services provided to some Americans must be distributed to all Americans.

Equity is a social concept in which all people receive the same standard of living. Equality is a legal concept in which all people share opportunities to achieve. Communism, which seeks to provide equity, has either failed or generally provides a lower standard of living than enjoyed by most Americans. World wide experience with equity has not shown significant benefits or longevity.

Consequently, I support using the NJ cannabis Social Equity Excise Fee for the good of all New Jersey tax payers. Whatever the value of goods and services that are involved should be distributed to all of us. For example, if educational, nutritional, or medical goods and services are provided to some people for the purpose of equity, the legal principle of equality must be satisfied as well. The value of those goods and services should be distributed to all of us all other New Jersey tax payers.

Comment: "The NJ School-Age Child Care Coalition (NJSACC) appreciates the opportunity to provide testimony to the NJ Cannabis Regulatory Commission. NJSACC envisions a NJ where every child has access to high-quality, inclusive out-of-school time (OST) programs that provide equitable and diverse experiences that maximize the full potential for all youth, families and communities. Using tax revenue from adult-use cannabis to support afterschool, OST and other youth development programs are a critical strategy for promoting equity and reinvesting in our underserved communities.

For every child in an OST program in NJ, three (3) more would participate if a program were accessible; consequently, 32% of NJ's youth would be enrolled in an OST program if one were available to them. To meet the needs of our youth and communities, these investments must be prioritized and sustained long-term. NJ has an opportunity to address the state's growing wait list as well as program gaps in rural areas by leveraging existing federal dollars and directing recreational cannabis revenue to support afterschool and OST programs.

NJSACC recommends that NJ dedicate at least 25% of revenue from the taxation of adult-use cannabis to expand access to afterschool statewide, particularly reinvesting funds in those communities hardest hit by the war on drugs. With a proven track record for preventing drug use and misuse, increasing resilience, and supporting positive youth development, investment in OST programs is a compelling use of state social equity tax dollars.

For teens and older youth, the hours between 3pm and 6pm are the riskiest hours as they are when juvenile crime, victimization, and drug use peak. Older youth who do not participate in structured activities after school are three times more likely to participate in risky behavior. OST is a safe space for students to participate in enrichment activities and help students build character traits like self-control and confidence. If NJ is considering the use of tax revenue to repair harm done to historically marginalized communities hit hardest by the war on drugs, OST programs provide protective factors for youth development and success. Six other states have already linked revenue from legalized marijuana sales to afterschool and out-of-school programming; NJ is well positioned to follow suit.

Illinois: In 2019, Illinois passed the Cannabis Regulation and Tax Act, which legalized adult-use cannabis and created the Restore, Reinvest, and Renew grant program.

Colorado: Denver is using a portion of the city's 3.5 percent special sales tax on marijuana products to help fund Healthy Lifestyles course.

California: Prop. 64 campaigns to legalize recreational marijuana, advocates are working to develop laws to establish afterschool programs as a prime beneficiary of the revenue.

NJSACC submits the following recommendations for consideration:

-Establish the NJ OST Advisory Commission Fund to support the goal of universal afterschool and OST. The Commission would expand access to quality afterschool and out-of-school time programs for youth across the state of NJ.

-The fund would award grants to all eligible afterschool and out-of-school time programs, including licensed and subsidized, school district operated, and city/town/municipally funded programs to build capacity and increase quality through professional development.

-The fund would award grants to youth prevention organizations that offer college and career readiness, apprenticeships and credentials to opportunity youth. This can include developing knowledge, skills, and character traits that are important for opportunity youth's career pathway development.

NJ's youth need and deserve safe, enriching afterschool and OST programs to aid in their development. Using tax revenue from adult-use cannabis to fund youth development programs, including afterschool and OST, is a good first step in social equity and community reinvestment. Thank you.

**Comment**: Dear Commission. Thank you for taking comments on what to do with the proceeds from the Cannabis Industry. In my opinion the funds need to be allocated to the severely underserved Black Communities of NJ, especially those in 07304 & 07305 as well as those convicted and jailed due to the war on drugs targeted at Black people. Two avenues to give back directly to Black Communities that can put the recipients on a path to wealth would be 1) Instead of the \$1,000 baby bond program that Gov. Murphy has proposed invest \$6,000 for every Black child that falls under the median income in NJ into an index ETF adding \$50 a month until they turn 21 years old. At the age of 21 years the recipient shall be required to complete a financial course to access a portion of the funds.

Funds should be allocated over time in logical increments allowing recipients the opportunity to withdraw portions of the funds at any time to purchase assets (ie: real estate) or for unforeseen emergencies. Funds should be completely dispersed to recipients by retirement age. This fund shall be restricted from any and all debt collectors including but not limited to the local, county, state or federal government. This fund shall not stand in the way of a recipient's ability to obtain scholarships for school nor grants in any way. 2) Any non-violent, victimless cannabis conviction that results in expungement should be accompanied with a program that provides a path to homeownership which includes a 20% down payment grant ensuring no PMI and some kind of payment assistance for the duration of the loan. Let's be clear. I am not asking for any of those affordable housing scams inflicted on Black people through HUD/CBGB Grants, Jersey City or the State of NJ, etc. NONE of those 95/5 rip-off schemes where Black wealth is stolen when the recipients want to retire. This program should be completely separate and devoid of any funds being paid back, ever. Recipients should be allowed to purchase a home wherever they want in NJ and not be beholden to the racist banking low, moderate, middle and upper income tracts on which mortgage loans are based. When possible, the Commission should find Black Owned & Black Run Banks and Organizations to assist recipients on their journey. Organizations like the African American Chamber of Commerce NJ, Earn Your Leisure (EYL) and Red Panda (Ian Dunlap) should be considered prior to selecting traditional non-Black run organizations. It would be great to see the State of NJ use the cannabis funds to close the astronomical wealth gap and be the first state to truly achieve economic equality.

## Subject matter: Social Equity Excise Tax Public Comment

Comment: Re: Tax revenue to fund institutional access to medical cannabis

I propose using a portion of the Social Equity Excise taxes to implement a program where the State of New Jersey produces, manufactures, and distributes medical cannabis for all qualified patients in state institutions.

In November 2015, Gov. Chris Christie signed into law A4587, a bill requiring facilities for the developmentally disabled to allow the administration of medical cannabis to qualifying patients.

As I said in a Trenton Times Op Ed in 2016 entitled, "It's time for N.J. to fully embrace medical marijuana:"

""The State of New Jersey must recognize its status as caregiver of last resort to the many patients who are under its care -- this applies not only to residents of facilities for the developmentally disabled, but also to residents in psychiatric hospitals, nursing homes, group homes, and hospices, as well as to inmates in correctional facilities.

I know these facilities. I worked for four years at Trenton Psychiatric Hospital and for 22 years at the New Jersey Department of Corrections (DOC). Some of the residents and inmates at these facilities suffer from cancer,

HIV/AIDS, seizures, multiple sclerosis, and other conditions that qualify for medical marijuana. There is no reason to withhold oral doses of medical marijuana from these patients.

The staff in these facilities is already trained to administer and account for controlled substances. They are trained to observe for side effects and adverse reactions. The State simply needs to develop policies and procedures to administer oral forms of marijuana to the patients in its care who qualify, under state rules, for this therapy. The medical cannabis could be grown and processed in secure greenhouses at the Rutgers University Agricultural School. The cannabis would then be manufactured into various edible products with specific doses of varying cannabinoid contents, ideally under the supervision of the New Jersey Board of Pharmacy. These products would then be distributed to institutions.""

The 2019 Jake Honig law has already called for guidelines for the dosage and administration of medical cannabis. As soon as these guidelines are adopted, they can be distributed to the medical staff at all state institutional facilities.

This program can result in tremendous savings of health care dollars. With the broad range of therapeutic effects of cannabis, it is not surprising to see that one or more additional problems are managed when the patient's qualifying condition is adequately treated. This represents significant savings on expensive pharmaceuticals. Additionally, with better managed and more stable chronic conditions in the institutions, savings are also realized in the reduced need for emergency transport, hospitalizations, and surgical procedures. Health care costs for inmates in the NJ DOC were \$142 million in 2011, according to nj.com. A 10% savings (\$14.2 million) is a very conservative estimate of reduced annual costs in just one department in state government when this program is fully implemented.

Additionally, public health will be improved, and New Jersey can be a model for institutional health care throughout the country.

I conceived, designed, and implemented a telemedicine program for the NJ DOC when I worked there. For this, I was awarded the Governor's Certificate of Appreciation for "improving government in New Jersey" on July 19, 2005. The 2014 Annual Report from the DOC notes that:

"Telemedicine continues to produce cost savings, as some 150 telemedicine sessions take place each month...telemedicine has saved hundreds of thousands of dollars in manpower and transportation costs."

Institutional access to medical cannabis, like the DOC telemedicine program, will result in considerable cost savings while improving patient care. Thank you."

**Comment**: "The American Civil Liberties Union of New Jersey (ACLU-NJ) submits this written testimony regarding the allocation of revenue raised from the social equity excise fee (SEEF) in the FY 2024 budget.

The ACLU-NJ is committed to ensuring that New Jersey achieves the promises of legalization – ending marijuanarelated arrests, building an equitable industry, and ensuring that revenue from legalization is reinvested into the communities most harmed by marijuana criminalization.

New Jersey's cannabis legalization law committed a significant portion of cannabis-related revenue – one hundred percent of the social equity excise fee and almost sixty percent of all cannabis sales tax revenue – to community reinvestment. While this was an important step towards beginning to repair the harms of marijuana prohibition, now is the time to ensure that this promise comes to fruition.

As the New Jersey Cannabis Regulatory Commission (CRC) make recommendations on how these funds should be allocated within the FY24 budget, ACLU-NJ's urges you to follow the lead of community members calling for

investment in resources that build access to opportunity and allow communities to recover from decades of criminalization and thrive. Community reinvestment funds can be used to support essential programs, like social services, housing and food assistance, educational support, harm reduction, and other services. These resources have been disinvested in for decades, and community members and advocates have emphasized over the course of both the FY23 and FY24 budget cycles that this is how cannabis funds can be used to best support their municipalities.

It is also vital that none of the cannabis revenue promised for community reinvestment is used to provide funding to law enforcement, criminal legal system stakeholders, or other related programs. New Jersey has spent over \$1 billion to enforce marijuana prohibition, and it is long past time for change. ACLU-NJ appreciates that this principle was highlighted in the CRC's recommendations to the Legislature and Governor in FY23, and urges the CRC to include this as a cornerstone of any recommendations going forward.

In addition to these substantive recommendations on how cannabis community reinvestment funds should be allocated, ACLU-NJ also calls on the CRC to work with partners within state government to create more transparency and accountability in this process:

- Create a public tool that tracks the funding set aside for community reinvestment and how it is being used to support new resources and opportunities, as well as an annual report on cannabis community reinvestment that tracks how reinvestment dollars are used over time.
- Institute a more participatory and community-driven process to determine how all community reinvestment from the cannabis sales tax revenue and SEEF should be used, including additional regional CRC SEEF hearings, annual legislative hearings on community reinvestment, and meetings with community-based organizations.
- Establish a Cannabis Community Reinvestment Advisory Board to inform the allocation of community reinvestment funds. The board should be made up of New Jerseyans directly impacted by criminalization, through the criminal legal system, child welfare, housing, immigration, education, and employment.

This moment calls for action and leadership. As New Jersey's cannabis industry grows and licensees and other businesses continue to financially benefit from changes in marijuana law, it is crucial that the communities most targeted by marijuana criminalization are not left behind. We, along with our partners, urge you to prioritize community voices in this process and to ensure transparency and accountability. "

**Comment**: "The social equity excise fee (SEEF) revenue should support full-time social services employees in economically disadvantaged impact zones. The people in these positions would work toward social equity outcomes in New Jersey:

Equitable cannabis markets for consumers and businesses Justice systems that ameliorate wrongs and support individual growth Social services in the communities that need them

Social equity is a long-term goal that requires investments in social services and reforms to policies and practices. Public recommendations on Wednesday night proposed funding for public libraries, youth development programs, and Black owned businesses. These are worthy programs with demonstrated benefits. But these plans to invest SEEF revenue do not meet another goal of the CRC - to create an innovative blueprint for states to approach social justice.

Current SEEF revenue should cover three full-time positions to start, then increase exponentially with the market. Three people can make a difference - people skilled in case management, organization, communication, and change. These people should serve Impact Zones that are also Economically Disadvantaged - Atlantic City, Camden, Jersey City, Newark, Paterson, and Trenton. Dedicated employees in dedicated positions can connect members of these communities to the government. They can also improve the government.

## Example 1: Legal support

The CRC is clearly separate from the court system, which has quickly and efficiently expunged records meeting specific criteria. A state employee could provide individual counseling for people whose cases were not automatically expunged. This employee could also create networks of NJ lawyers who can contribute their time and talents to this cause. Beyond individual counseling, they can recommend proactive reform of remaining racist policies. This will show that social equity in NJ does not end with cannabis.

## Example 2: Economic reform

The CRC is doing all the right things to support individuals and small businesses from communities that have been historically excluded from profitable industries. A state employee could continue and expand this work. But even with this support, entrepreneurs cannot succeed in a market flooded with multi state operators (MSOs). Drawing support from local experts, a state employee can research best practices and recommend reforms that will prioritize entrepreneurs at all levels - licensing, banking, operation, taxation. For the cannabis market to be equitable, an individual with a record and limited capital has to have a chance against a large corporation headquartered out of state. This will only happen if policies guide the market.

## Example 3: Social services

Social equity extends far beyond cannabis. Remaining SEEF revenue should be invested into existing social services in Atlantic City, Camden, Jersey City, Newark, Paterson, and Trenton. The social services most directly related to the failed war on drugs include education, childcare, substance use disorder treatment, and mental health treatment. As revenue increases, additional state employees can provide individual counseling and suggest reform in all of these areas as suggested above.

Many states allocate their excise fees to schools, mental health, substance use prevention and disorder treatment, and business investments. Not all states disburse those funds. It has been reported that New York State "is sitting on" over one million dollars in tax revenue collected since 2014. It does not look good for Pennsylvania that half of their sugar-sweetened beverage tax revenue went to the General Fund instead of early education. To avoid these problems, New Jersey needs people to initiate programs and keep them running. This is not an investment in bureaucracy with a bloated payroll. This is an investment in people to implement the state's commitment to social equity and resources to support communities who deserve it most.

Subject matter: "How Should Money from Cannabis Legalization Be Spent? A Statewide Survey of New Jersey Residents Suggests Public Health and Education

**Comment**: We are researchers from Rutgers University and Drexel University who study crime and justice. Here we share a brief summary of our recent findings about New Jersey residents' views of the impacts of cannabis legalization and decriminalization.

We collected and analyzed data in summer of 2022 to address this topic (from 1,006 respondents across all 21 counties). The data were weighted to be representative of the residential adult population of New Jersey; in other words, our findings present an accurate depiction of the views of all NJ residents.

For the Commission's purposes, we share here some of the findings relevant to social equity and the distribution of revenue stemming from sales taxes on cannabis. Specifically, people were asked "In your opinion, what should be the state government's top priority when it comes to using the sales tax revenue generated from legal cannabis purchases?" They were then instructed to choose the top choice among a series of response categories.

The results show the percentage of people ranking each option and the most important priority for spending:

- 23% -- Public and community health initiatives
- 22% -- Education
- 13% -- Transportation and infrastructure
- 13% -- Affordable housing development
- 10% -- Funding for police, courts, and prisons\*
- 4% -- Campaigns on the dangers of substance use
- 15% -- Other/don't know

When this question was asked a second time, and people were instructed to pick a different option, the results were similar, with education and public health responses still coming in first and second, but switching places as the most important. Overall, public health and education priorities were the top concerns among residents. Between the two questions, about half of all respondents indicated that the revenue should be spent on public health initiatives and education.

These numbers, keep in mind, reflect the views of NJ residents overall. How these findings may differ if we analyzed the subsample of residents who live in the identified impact zones is an open question. This is important as residents of these areas are likely much more attuned to the specific needs of their communities and most impacted by this legislation and the problems it seeks to address. If the Commission is interested this question we would be glad to explore it further and can provide a more detailed report.

**Comment**: "Build resilient NJ communities by supporting and expanding the state's investment in the Prevention Hubs: a statewide network of 21 county prevention agencies that provide effective and evidence-based substance use prevention programming and resources to individuals, families and communities.

The Cannabis Regulatory Commission has invited comments regarding the distribution of cannabis-related revenues, specifically those accrued via the Social Equity Excise Fee (SEEF). We applaud the Governor, Legislature and CRC for their commitment to the goal of building social equity through the distribution of these resources.

In order to ensure that these new funds are maximized, we urge these funds be used to support and expand upon critical infrastructure that exists rather than creating a new system that may duplicate current efforts. There is currently a well-established system of substance use prevention agencies that are providing prevention services and connecting communities to treatment and recovery services, including connections to services related to social, health and other needs. The New Jersey Prevention Hubs – supported by the Department of Human Services, Division of Mental Health and Addiction Services (DMHAS) – are housed in prevention agencies in each of NJ's 21 counties and provide essential local resources to individuals, families and communities. These agencies have been engaging youth, parents and community leaders and delivering universal prevention interventions in schools and communities for the last 10 years. The agencies are long-standing and trusted non-profit organizations in their communities and have deep ties and cultural knowledge to best serve their localities.

With DMHAS support, this statewide network of Prevention Hub agencies provides resources to schools and communities, particularly for vulnerable groups such as children and older adults. The Prevention Hub agencies regularly work with multiple sectors in the community such as local law enforcement, local prosecutor's offices, veterans' groups, senior centers and others. They provide evidence-based programs like Strengthening Families, WISE (Wellness Initiative for Senior Education), Over the Counter Medication Safety Training, and tailored, culturally appropriate programming for specific community groups in multiple languages. They build capacity among local schools by providing training and delivering evidence-based prevention programs such as Don't Get Vaped In, PreVenture, LifeSkills, and others, to reduce substance use risk among youth, educate them on alcohol, marijuana, tobacco, and other drugs, and build resiliency by providing healthy coping skills for stress and mental health. These agencies also provide schools with training and capacity building on universal prevention techniques such as screening with evidence-based tools such as SBIRT (Screening to Brief Intervention and Treatment), providing resources and training to school personnel. These hubs provide a one-stop-shop for local communities and regularly make referrals and connections to resources and providers, address social determinants of health, and addiction and mental health needs. Rather than creating new infrastructure that may duplicate efforts and cause confusion, we urge the Governor, Legislature, and the CRC to wisely spend the limited resources provided by the CREAMM Fund on strengthening and expanding the existing and effective Prevention Hub Agencies, to continue to provide evidence-based and appropriate prevention resources to our youth, families and communities.

Thank you for the opportunity to speak today about the proposed uses of Cannabis's tax revenue. I am Malissa Arnold, from the Prevention Coalition of Mercer County, and the Mercer Council on Alcoholism and Drug Addiction. The Coalition represents all sectors of the community and is proud of their efforts to keep Mercer County healthy safe and responsible by making environmental changes to increase protective factors and reduce risk factors, especially for are most vulnerable populations while always respecting cultural proficiency.

We are particularly concerned with the vulnerable, developing minds of our young people. Funding and priorities should be placed on education efforts for safety. We need campaigns for parental education on the differing impacts that this substance has on young adults, as opposed to the effects on adult brains, safety campaigns about safe storage and use around children, and emphasize these issues as we have in the past with alcohol.

In the CRC's recommendations to the governor, released in the fall od 2022, many suggestions for services in mental health, schooling, workforce preparation, early intervention services, out of school programs and business preparation services were very well received. We feel that these are very needed and many compassionate, involved groups and organizations are working very hard to offer them. An investment in these organizations so that they can build their capacity, serve longer hours, hire and train more staff, more clinicians, and serve more age ranges would be an efficient and mindful use of these public funds.

One of these programs that has made an impact on the community are the School Based Youth Support System programs (SBYSSP). These valuable programs are already in our schools, many in impact zones, and with increased capacity could spread to all impact zones. Save the school based youth support system's programs. Give them steady funding and allow them to expand their reach through increased capacity.

Another area that needs to be funded and supported is technologies for testing and screening for cannabis use for highway safety, job safety, and for schools. Being under the influence of cannabis has lead to safety issues, and accurate and fast technology needs to exist to keep our communities safe. Retailers, schools, parents, and enforcement need reliable, non-biased data to help keep our roads and workers functioning and lower risk. In addition, cannabis retailers should have responsible serving and selling criteria and training.

Please increase protective factors of positive activities for our youth by increasing the ability of recreation centers, libraries, youth support organizations, community groups, summer camps, out of school programs, the arts, and substance free activities to reach our young people. These programs help youth and families learn better communication, gives positive interactions with adults, tutors, mentors and trainings that have a overall positive effect on our communities as a whole.

Uniform labeling standards for all products, and true penalties for those selling imitation products to youth, or in an unlicensed place of business need to be enforced to protect the health screening practices for these products and stop the accessibility to unlicensed products to our residents- especially youth.

Incentives to increase students and careers in the mental health, addiction, and social services areas, especially for minority students are needed so that more can serve the greater needs of our community. Increasing the capacity of these safety nets lead to less law enforcement interventions, and result in stronger, healthier communities.

Early Intervention Services need to be expanded to include younger ages, accommodate longer hours for accessibility, and accessibility and access to public transportation. We have seen a great benefit to these programs but"
