Jim opened the meeting followed by the flag salute by Peggy Carrigg. Minutes for the January 13 & March 10, 2017 need to be approved.

Membership:

Introduction of committee and guests were announced.

Handouts/Articles reviewed:

Article 1) DGE March 2017 Gaming Revenue Results from Attorney General. Casino Win from the industry was \$200.1 mill compared to \$187.5 mill in March 2016. (6.7% increase). Internet gaming win was \$21.7 mill in March compared to \$15.5 mill in prior period. (40.2% increase). Tax information – (March) total gaming taxes were \$19.6 mill. These taxes reflect 8% of taxable casino gross revenue and 15% of Internet gaming gross revenue.

Article 2) Peggy Carrigg shared a letter she wrote to CEO of Hard Rock Café regarding advantages of hiring seniors and individuals with disabilities. Highlights of letter:

- -Businesses may receive tax credits and/or other incentives. This tax includes Disabled Access Credit, Barrier Removal Tax deduction and work opportunity tax credit. These tax credits could range from \$1200 to \$9600.
- -Studies, which amounts are often covered by the Disabled Access Credit, demonstrates most accommodations cost nothing or less than \$500.00.
- -A thirty year analysis by DuPont de Nemours show that persons with disabilities have equal or higher performance ratings, better retention rates and less absenteeism.

Senator President Stephen Sweeney re-appointed James A. Carney of Egg Harbor Township to the Casino Revenue Fund Advisory Commission.

Sports betting: Out of 130 cases, Supreme Court selected 6. (Sports betting was including in the 6). If the ban for sports betting lifted, AC casinos are ready for operations. 15% of SB revenue should go to CRFAC.

Online betting: Visits to the AC casinos have increased due to online gaming. 80% of people who play online have never been to AC (brick & mortar). However, 15% of the 80% have since visited the casinos.

Highlights in AC:

Revenue #'s increased for 1st time in 10 years.
Internet revenue is higher than brick and mortar casinos.
Taj Mahal sold to Hard Rock – Should be up and running summer of 2018.
Steel Pier (Eye in Sky) should be opened this summer 2017.

Fiscal Update – Desmond Webb provided CRFAC Summary & Projection report covering fiscal years 2014 through projected 2018.

Internet gaming had a 30% increase since start up.
