Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

Ortzman, pursuant to <u>N.J.S.A.</u> 5:12-89(e), with a multi casino endorsement, pursuant to <u>N.J.S.A.</u> 5:12-91.1; and permitted him, pursuant to <u>N.J.A.C.</u> 13:69C-2.6, to assume the duties and exercise the powers of Senior Vice President and General Manager for Bally's Park Place Inc. and Showboat Atlantic City Operating Company, LLC, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 c; *N.J.S.A.* 5:12-89 b (1) and (2); and *N.J.A.C* 13:69C-2.7 (PRN 1211201) (12-05-09-05; transcript pages 18-21).
- 6. By a vote of 3-0, found Richard Flaherty qualified to serve as a Member of the Board of Directors of Boyd Gaming Corporation, in accordance with <u>N.J.S.A.</u> 5:12-85.1c, <u>N.J.S.A.</u> 5:12-85.1d, <u>N.J.S.A.</u> 5:12-89b (1) and <u>N.J.S.A.</u> 5:12-89b (2) and *N.J.A.C.* 13:69C-2.7 (ruling number 12-05-09-06; transcript pages 21-23).

- 7. By a vote of 3-0, approved John Darville's requested relief and waived the post employment restriction, to permit Mr. Darville employment with DGMB Casino, LLC, (d/b/a Resorts Casino Hotel), as a Surveillance Operator, pursuant to *N.J.S.A.* 5:12-60b (2) and subject to appropriate registration or licensure (PRN 1221201) (PE-10; transcript pages 25-27).
- 8. Considered the petition of RIH Acquisitions NJ, LLC and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Denis Dooley, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers of a Member of the Audit Committee and Chair of the Compliance Committee of RIH Acquisitions, NJ, LLC, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 c; *N.J.S.A.* 5:12-89 b (1) and (2); and *N.J.A.C* 13:69C-2.7 (PRN 1251201) (ruling number 12-05-09-08; transcript pages 23-25).
