Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- 1. By votes of 3-0, ratified the minutes of June 13, 2012 (transcript page 8).
- 2. Vice Chair Harrington read into the record a Resolution commending Chair Linda M. Kassekert for her distinguished service to the Commission. Masland, Lance W. McCallion, Kathleen J. Meiklejohn, Karolyn M. O'Brien, Peter J. Perfetti, Christopher Pompei, Elierjohn Rodriguez, James C. Roesberg, Virginia L. Schofield, Dominic A. Tedeschi, Jr., John R. Teti, George H. Wilson and Joann M. Young casino key employee licenses (Exhibit EL-2\*);

By a vote of 3-0, granted the casino key employee license application of Raymond C. Bertschy and for qualification as Vice President of Food and Beverage for Tropicana Atlantic City Corporation (Ruling number 12-07-11-03-A); and

By a vote of 3-0, granted the casino key employee license application of Gerald J. DelPrete and for qualification as Vice President of National Marketing for Golden Nugget Atlantic City, LLC (Ruling number 12-07-11-03-B; transcript pages 23-26).

- 4. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Wayne Chiw, Sharon L. Deen, Mary F. Harper, Richelle Y. Ruemeli, Teresa Schwartz and Shurlana P. Stewart (Ruling number 12-07-11-04; transcript pages 26-27).
- Considered the amended joint petition of Bally's Park Place, Inc. (d/b/a Bally's Atlantic City), Boardwalk Regency Corporation (d/b/a Caesar's Atlantic City) Showboat Atlantic City Operating Company, LLC. (d/b/a Showboat Casino Hotel) and Harrah's Atlantic City Operating Company, LLC (d/b/a Harrah's Casino Hotel) and issued the following ruling:

By a vote of 3-0, approved the petition and issued a temporary casino key employee license to Marvin W. Case, pursuant to *N.J.S.A.* 5:12-89(e), with a multi casino endorsement, pursuant to *N.J.S.A.* 5:12-91.1; and permitted him to assume the duties and exercise the powers of Director of Enterprise Shared Services Collections for Bally Park Place, Inc., Boardwalk Regency Corporation, Harrah's Atlantic City Operating Company, LLC and Showboat Atlantic City Operating Company, LLC. Further, granted the petitioners' request to waive the residency requirement, as provided for in *N.J.S.A.* 5:12-89(b) 4 (DGE-PRN 1641202) (12-07-11-05; transcript pages 27-31).

- 6. By a vote of 3-0, found Mark A. Clayton qualified to serve as a Member of the Compliance Committee for Caesars Entertainment Corporation, in accordance with *N.J.S.A.* 5:12-85.1c, *N.J.S.A.* 5:12-85.1d, *N.J.S.A.* 5:12-89b (1), *N.J.S.A.* 5:12-89b (2) and *N.J.A.C.* 13:69C-2.7 (ruling number 12-07-11-06; transcript pages 31-33).
- 7. By a vote of 3-0, found Eric Hession qualified to serve as a Member of The Capital Committee for Caesars Entertainment Corporation, in accordance with *N.J.S.A.* 5:12-85.1c, *N.J.S.A.* 5:12-85.1d, *N.J.S.A.* 5:12-89b (1), *N.J.S.A.* 5:12-89b (2) and *N.J.A.C.* 13:69C-2.7 (ruling number 12-07-11-07; transcript pages 33-35).
- 8. Considered the petition of RIH Acquisitions NJ, LLC and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Honorable Frederick P. Devesa, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers of a Member of the Audit Committee of RIH Acquisitions NJ, LLC, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 c; *N.J.S.A.* 5:12-89 b (1); *N.J.S.A.* 5:12-89 b (2); and *N.J.A.C* 13:69C-2.7 (DGE-PRN 1741201) (ruling number 12-07-11-08; transcript pages 35-37).

9. Considered the petition of RIH Acquisitions NJ, LLC and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Honorable Wilbur H. Mathesius, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers of a Member of the Audit Committee of RIH Acquisitions NJ, LLC, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 c; *N.J.S.A.* 5:12-89 b (1); *N.J.S.A.* 5:12-89 b (2); and *N.J.A.C* 13:69C-2.7 (DGE-PRN 1881203) (ruling number 12-07-11-09; transcript pages 38-40).

In accordance with Resolution No. 11-12-14-03, the next closed session of the commission shall be held on Wednesday, August 8, 2012 at 9:30 a.m. in the commission offices (transcript page 40).
