Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

Chairman Levinson, Vice Chair Harrington and Commissioner Cooper, congratulated and recognized the following seven Commission employees for achieving ten to thirty five years of State Service. 8. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Gary Imperatore; and granted the resubmitted application of Mr. Imperatore, for a casino key employee license (DKT-12-0013-CK) (Ruling number 13-10-16-08; transcript pages 23-25).

By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Domingo Cruz; and granted the initial application of Mr. Domingo, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 12-0019-CK) (Ruling number 13-10-16-09; transcript pages 25-27).
10. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Aharon M. 12. By a vote of 3-0, approved the stipulation of settlement, as amended, between the Division of Gaming Enforcement and Lashanna P. Muhammad; and granted the initial application of Ms. Muhammad, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0018-CK) (Ruling number 13-10-16-12; transcript pages 30-33).
13. Considered the petition of Trump Entertainment Resorts, Inc. and issued the following ruling:
- By a vote of 3-0, adopted the draft resolution and found Michael Elkins, qualified to serve as a Member of the Board of Directors of Trump Entertainment Resorts, Inc., in accordance with N.J.S.A. 5:12-85.1c, N.J.S.A. 5:12-85.1d, N.J.S.A. 5:12-89b(1), N.J.S.A. 5:12-89b(2) and N.J.A.C. 13:69C-2.7 (Ruling number 13-10-16-13; transcript pages 33-35).
14. Considered the Joint Petition of Bally's Park Place, Inc. (*d/b/a* Bally's Atlantic City), Boardwalk Regency Corporation (*d/b/a* Caesar's Atlantic City), Showboat Atlantic City Operating Company, LLC. (*d/b/a* Showboat Casino Hotel), and Harrah's Atlantic City Operating Company, LLC (*d/b/a* Harrah's Resort Atlantic City) and issued the following ruling:
- By a vote of 3-0, approved the joint petition and granted Grant Lindle, a multi casino endorsement upon his casino key employee license, pursuant to N.J.S.A. 5:12-91.1 for Bally's Park Place, Inc., Boardwalk Regency Corporation, Showboat Atlantic City Operating Company, LLC and Harrah's Atlantic City Operating Company, LLC (PRN 2731303) (13-10-16-14; transcript pages 35-38).
15. Considered the joint petition of MGM Resorts International, Boyd Gaming Corporation, and the Marina District Development Company, LLC and issued the following ruling:
- By a vote of 3-0, granted the requested relief and approved the amendment to the surface parking lot lease (Block 576, Lot 1.07) between Marina District Development Company, LLC and MAC CORP., decreasing the termination notice period from six months to three months (PRN 2681306) (13-10-16-15; transcript pages 38-42).


There being no members of the public to address the Commission, the meeting adjourned at 11:00 a.m.
