Sutton (Ruling numbers 14-01-08-07-A; 14-01-08-07-B; 14-01-08-07-C; 14-01-08-07-D, 14-01-08-07-E, 14-01-08-07-F, 14-01-08-07-G, 14-01-08-07-H; 14-01-08-07-I, 14-01-08-07-J, 14-01-08-07-K; transcript pages 17-18).
- 8. By a vote of 3-0, approved the petition of Marina District Development Company, LLC (*d/b/a* Borgata Hotel Casino and Spa), and issued a temporary casino key employee license to Stephen W. Nathan, pursuant to *N.J.S.A.* 5:12-89(e) and permitted him,

pursuant to <u>N.J.A.C.</u> 13:69c-2.6 and <u>N.J.A.C.</u> 13:69c-2.7 (c), to assume the duties and exercise the powers of the Vice President of Marketing of Marina District Development Company, LLC, pending plenary licensure and qualification. (PRN 3471302) (14-01-08-08; transcript pages 19-21).

9. Considered the petition of Caesars Entertainment Corporation and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and found Frederick J. Kleisner, qualified to serve as a Member of the Board of Directors for Caesars Entertainment Corporation, in accordance with *N.J.S.A.* 5:12-85.1c, *N.J.S.A.* 5:12-85.1d, *N.J.S.A.* 5:12-89b(1), *N.J.S.A.* 5:12-89b(2) and *N.J.A.C.* 13:69C-2.7 (PRN 1571302) (Ruling number 14-01-08-09; transcript pages 21-24).

- 10. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Ian G. Nebbett; and granted the resubmitted application of Mr. Nebbett, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0028-CR) (Ruling number 14-01-08-10; transcript pages 24-26).
- 11. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Ronald J. Rodriguez; and granted the resubmitted application of Mr. Rodriguez, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0027-CR) (Ruling number 14-01-08-11; transcript pages 26-28).
- 12. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Anthony Ciallella; and granted the resubmitted application of Mr. Ciallella, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0017-CR) (Ruling number 14-01-08-12; transcript pages 28-30).
- 13. Considered the petition of Caesars Interactive Entertainment New Jersey, LLC and Caesars Acquisition Company and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Don R. Kornstein, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers of an Independent Member of the Board of Directors of Caesars Acquisition Company, pending plenary qualification, subject to the conditions contained in *N.J.S.A.* 5:12-85.1c and *N.J.A.C* 19:43-2.7 (PRN 0061401) (Ruling number 14-01-08-13; transcript pages 30-33).
