Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- 1. By a vote of 2-0-1 (Chairman Plousis abstained), ratified the minutes of December 19, 2017 public meeting (transcript pages 9-10).
- 2. By a vote of 3-0, Sharon Anne Harrington was elected Vice Chair of the Commission until the Reorganization Meeting in January 2018 (ruling number 18-01-10-02; transcript pages 10-11).

Tropea (Ruling numbers 18-01-10-06-A, 18-01-10-06-B, 18-01-10-06-C, 18-01-10-06-I, 18-01-10-06-E, 18-01-10-06-F, 18-01-10-06-G, 18-01-10-06-H, 18-01-10-06-I, 18-01-10-06-J, 18-01-10-06-K, 18-01-10-06-L; transcript pages 14-15).
- 7. By a vote of 3-0, found that John P. Arthur, Lewis D. D'Agostino, David G. Davidson, Stephanie L. Derrick, Karen S. Ferus, Nicholas J. Fiadino, IV, Lisa G. Gill, William J. Hash, Jr., James M. Knights, Barbara A. Lang, Nia N. Little, Melissa P. Lutz, Michael M. Nocito, Piyush P. Patel, Robert J. Schulte, Richard T. Shehan, Russell R. Stokes, Robin C. Taylor, Barbara Ann C. Travis and Karen S. Tyler's casino key employee licenses lapsed, pursuant to *N.J.A.C.* 19:41A-6.1 (f) of the regulation. Paul J. Jenkins, Jr. was administratively removed from consideration (Ruling numbers 18-01-10-07-A; 18-01-10-07-B; 18-01-10-07-C, 18-01-10-07-D, 18-01-10-07-E, 18-01-10-07-L, 18-01-10-07-G, 18-01-10-07-H, 18-01-10-07-J, 18-01-10-07-P, 18-01-10-07-L, 18-01-10-07-R, 18-01-10-07-S, 18-01-10-07-T, 18-01-10-07-U; transcript pages 15-17).
- 8. Considered the joint petition of Tropicana Atlantic City Corp, (*d/b/a* Tropicana Casino and Resort) and Tropicana Entertainment, Inc., and issued the following ruling:
 - By a vote of 3-0, approved the petition and issued a temporary casino key employee license to Christopher J. Capra, pursuant to <u>N.J.S.A.</u> 5:12-89(e), and permitted him to assume the duties and exercise the powers of Vice President of Internet and Online Marketing for Tropicana Atlantic City Corp., and Tropicana Entertainment Inc., pending plenary qualification, subject to the conditions contained in <u>N.J.S.A.</u> 5:12-85.1; <u>N.J.A.C.</u> 13:69C-2.6; and <u>N.J.A.C.</u> 13:69C-2.7 (PRN 0051801) (17-01-10-08; transcript pages 17-22).

9. Considered the joint petition of Marina District Development Company, LLC and MGM Resorts International, and issued the following ruling:

By a vote of 3-0, approved the petition and issued a temporary casino key employee license to Gregg Lowe, pursuant to <u>N.J.S.A.</u> 5:12-89(e), and permitted him to assume the duties and exercise the powers of Vice President of IT Operations for MGM Resorts International, pending plenary qualification, subject to the conditions contained in <u>N.J.S.A.</u> 5:12-85.1 c; <u>N.J.S.A.</u> 5:12-89b (1); <u>N.J.S.A.</u> 5:12-89b (2); and <u>N.J.A.C.</u> 13:69C-2.7 (d) (PRN 0051892) (17-01-10-09; transcript pages 22-25).

In accordance with Resolution No. 17-12-19-03, the next closed session of the Commission shall be held on Wednesday, February 7, 2018 at 9:30 a.m. in the Commission Offices (transcript pages 25-26).

There being no members of the public to address the Commission, the meeting adjourned at 10:46 a.m.
