Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

- By a vote of 3-0, found that Ronald E. Auer, Judy Banning, Robert L. Boughner, Joseph J. Garber, Felix Kogan, Luis N. Lozano, Ricky S. Mazer, Nicole E. McTague, Jacqueline T. Morrison and John J. Wolf casino key employee licenses lapsed, pursuant to <u>N.J.A.C.</u> 19:41A-6.1 (f) of the regulations' (Ruling numbers 19-06-11-06-A; 19-06-11-06-B; 19-06-11-06-C, 19-06-11-06-D, 19-06-11-06-E, 19-06-11-06-F, 19-06-11-06-G, 19-06-11-06-H, 19-06-11-06-I, 19-06-11-06-J; transcript pages 18-20).

- 9. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Edward Weeks; and granted the initial application of

Mr. Weeks, for a casino key employee license, subject to compliance with certain financial and reporting conditions as provided for in the stipulation (DKT 19-0014-CK) (Ruling number 19-06-11-09; transcript pages 23-25).

- By a vote of 3-0, adopted the draft resolution and found Denise M. By a vote of 3-0, approved the applicants sealing request and redacted portions of exhibit D-1.

The Commission heard presentations of the applicant and the testimony of Thomas R. Reeg, Chief Executive Officer of Eldorado Resorts, Inc.; Anthony Carano, Chief Operating Officer of Eldorado Resorts, Inc.; and Stephen Callender, Senior Vice President of Regional Operations of Eldorado Resorts, Inc.

The commission considered the witnesses testimony, written submissions, petition, exhibits and oral arguments presented and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and found Eldorado Resorts, Inc., and its Entity and Individual Qualifiers, plenarily qualified, as the new parent holding company of casino licensee, Tropicana Atlantic City Corp, based upon the findings and rulings and subject to the conditions specified therein (ruling number 19-06-11-21; transcript pages 54-149).

In accordance with Resolution No. 18-12-05-03, the next closed session of the Commission shall be held on Wednesday, July 10, 2019 at 9:30 a.m. in the Commission Offices (transcript page 150).

There being no members of the public to address the Commission, the meeting adjourned at 12:57 p.m.
