In furtherance of Governor Philip D. Murphy's Executive Order 103 (2020), the Casino Control Commission's meeting was held via in person and remote technology. The public listened telephonically by calling the telephone number and access number provided on the Commission's website, and public comments were accepted via e-mail.

Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act, the Commission considered and took formal action on the following matters:

- 1. By a vote of 3-0, ratified the minutes of September 10, 2025 (transcript pages 9-10).
- 2. By a vote of 3-0, granted the initial applications of Zion A. Bond-Gonzalez, Ralph Crespo, Destiny G. DelRio, Tariq N. Jackson, David Rolo, Corey C. Schmidt and Matthew Walczak, for casino key employee licenses (Exhibit EL-1*; transcript pages 10-12);

By a vote of 3-0, remanded the initial application of Nicole A. Blaylock for a casino key employee license to a hearing (Exhibit EL-1*; transcript pages 12-13);

By a vote of 3-0, remanded the initial application of James K. McMackin, for a casino key employee license to a hearing (Exhibit EL-1*; transcript pages 12-13);

By a vote of 3-0, remanded the initial application of DaZhaona A. Moses, for a casino key employee license to a hearing (Exhibit EL-1*; transcript pages 12-13); and

By a vote of 3-0, remanded the initial application of Jelitza M. Smith, for a casino key employee license to a hearing (Exhibit EL-1*; transcript pages 12-13).

3. By a vote of 3-0, granted the resubmitted applications of Rubayet H. Chowdhury (a/k/a Saduragaman Chowdhury Nhad), Basil V. DiCerbo, Joseph Gerace, 5th, Barry G. Larro, Antonio C. Mancella, Victoria R. Marr (a/k/a Victoria R. Witkowski), Indalecsio Ortiz (a/k/a Indy Ortiz), Edward J. Parkes, Glenn A. Pompo, James J. Prettyman, Rene A. Sagun and Michael M. Turon, for casino key employee licenses (Exhibit EL-2*; transcript pages 13-16);

By a vote of 3-0, granted the resubmission application of Yesenia E. Avalos (a/k/a Yesenia E. Ayala), for a casino key employee license; and waived the residency requirement, as provided for in N.J.S.A. 5:12-89(b) 4 (Exhibit EL-2*; transcript page 16-17);

By a vote of 3-0, granted the resubmission application of Michael A. Pompei, for casino a key employee license, with a multi-casino endorsement, pursuant to <u>N.J.S.A.</u> 5:12-91.1; and for qualification as Regional Human Resources Vice President for Boardwalk Regency Corporation, LLC (d/b/a Caesars Atlantic city, LLC), Harrah's Resort Atlantic City and Tropicana Atlantic City Corp (Exhibit EL-3*; transcript pages 17-19); and

By a vote of 3-0, granted the resubmitted casino key employee license application of Timothy R. Stafford, and for qualification as Vice President Player Development for AC Ocean Walk, LLC (d/b/a Ocean Casino Resorts) (Exhibit EL-3*; transcript pages 19-20).

4. Temporary casino key employee licenses were issued between September 1, 2025 and September 30, 2025, pursuant to Delegation of Authority Resolution Number 22-01-12-11-B to the following applicants: Robert Bradley, Alexa C. Hart, Jeffrey C. Jamieson, Vivian Lam (a/k/a Ngoc Vi Lam; Ngoc V. Vuu), Norman E. Seid, Ivelisse Trinidad (a/k/a Ivy Trinidad; Ivelisse Trinidad-Crespo) and Andrea P. Woodson (a/k/a Andrea P. Wyatt) (Exhibit EL-4*; transcript pages 20-23).

- 5. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Douglas S. Arrington and Joseph J. Mangiaracina (Ruling numbers 25-10-08-05-A, 25-10-08-05-B; transcript pages 23-24).
- 6. By a vote of 3-0, found that John R. Costa, Nancy L. Hughes, Timothy L. Thomas, Darren J. Tomlinson and Vina Vang, casino key employee licenses lapsed, pursuant to <u>N.J.A.C.</u> 19:41A-6.1 (f) of the regulation. (Ruling numbers 25-10-08-06-A, 25-10-08-06-B, 25-10-08-06-C, 25-10-08-06-D, 25-10-08-06-E; transcript pages 24-26).
- 7. Considered the initial application of Darcey A. Borden for a casino key employee license and issued the following ruling:
 - By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Applicant; and granted the initial application of Darcey A. Borden, for a casino key employee license, subject to compliance with the terms and conditions as provided for in the stipulation (DKT 25-0144-SI) (Ruling number 25-10-08-07; transcript pages 26-30).
- 8. Considered the resubmission application of Mary Martinez for a casino key employee license and issued the following ruling:
 - By a vote of 3-0, found Mary Martinez ("Applicant"), disqualified, pursuant to <u>N.J.S.A.</u> 5:12-80 (b), <u>N.J.S.A.</u> 5:12-80 (d), <u>N.J.S.A.</u> 5:12-86 (b) and <u>N.J.S.A.</u> 5:12-89 (b); denied Applicant's resubmitted application for a casino key employee license; and revoked Applicant's casino key employee license (DKT 25-0105-CR) (Ruling number 25-10-08-08; transcript pages 30-32).
- 9. Considered the initial application of Jacqueline Robinson, for a casino key employee license and issued the following ruling:
 - By a vote of 3-0, found Jacqueline Robinson ("Applicant"), disqualified, pursuant to <u>N.J.S.A.</u> 5:12-80 (b), <u>N.J.S.A.</u> 5:12-80 (d), <u>N.J.S.A.</u> 5:12-86 and <u>N.J.S.A.</u> 5:12-89; and denied Applicant's initial application for a casino key employee license (DKT 25-0122-CK) (Ruling number 25-10-08-09; transcript pages 32-35).
- 10. Considered the initial application of Yesseyda Santana, for a casino key employee license and issued the following ruling:
 - By a vote of 3-0, found Yesseyda Santana ("Applicant"), disqualified, pursuant to *N.J.S.A.* 5:12-80 (b), *N.J.S.A.* 5:12-80 (d), *N.J.S.A.* 5:12-86 and *N.J.S.A.* 5:12-89;

and denied Applicant's initial application for a casino key employee license (DKT 25-0106-CK) (Ruling number 25-10-08-10; transcript pages 36-38).

11. Considered the resubmission application of Charles Evans for a casino key employee license and issued the following ruling:

By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Applicant; and granted the resubmission application of Charles Evans, for a casino key employee license, subject to compliance with the terms and conditions as provided for in the stipulation (DKT 25-0095-CR) (Ruling number 25-10-08-11; transcript pages 38-41).

12. Considered the initial application of Joshua Cruz for a casino key employee license and issued the following ruling:

By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Applicant; and granted the initial application of Joshua Cruz, for a casino key employee license, subject to compliance with the terms and conditions as provided for in the stipulation (DKT 25-0123-CK) (Ruling number 25-10-08-12; transcript pages 41-43).

13. Considered the initial application of Marshall Davis, for a casino key employee license and issued the following ruling:

By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Applicant; and granted the initial application of Marshall Davis, for a casino key employee license, subject to compliance with the terms and conditions as provided for in the stipulation (DKT 25-0133-SI) (Ruling number 25-10-08-13; transcript pages 43-51).

- 14. Adjourned the consideration of the initial casino key employee licensure and plenary qualification of Travis T. Truong, to serve Vice President Asian Marketing for Marina District Development Company, LLC (d/b/a Borgata Hotel Casino & Spa) to the November 12, 2025 public meeting (transcript page 51).
- 15. Considered the Joint Petition of Boardwalk 1000, LLC (*d/b/a* Hard Rock Hotel & Casino Atlantic City) and HR Atlantic City, LLC, and issued the following ruling:

By a vote of 3-0, approved the petition and issued a temporary casino key employee license to Jon Morosky, pursuant to *N.J.S.A.* 5:12-89b, *N.J.S.A.* 5:12-89e and *N.J.A.C.*

19:41A-5.3; with a multi casino endorsement, pursuant to <u>N.J.S.A.</u> 5:12-91.1; and permitted Jon Morosky to assume the duties and exercise the powers of Vice President of Table Games for Joint Petition of Boardwalk 1000, LLC (*d/b/a* Hard Rock Hotel & Casino Atlantic City) and HR Atlantic City, LLC, pending plenary qualification; subject to the conditions contained in <u>N.J.S.A.</u> 5:12-85.1 and <u>N.J.A.C.</u> 13:69C-2.6 (PRN 2582502) (25-10-08-15; transcript pages 51-55).

16. Considered the petition of Marina District Development Company, LLC (d/b/a Borgata Hotel Casino & Spa), and issued the following ruling:

By a vote of 3-0, approved the petition and issued a temporary casino key employee license to Allison Smith Mitchell, pursuant to <u>N.J.S.A.</u> 5:12-89b(4), <u>N.J.S.A.</u> 5:12-89e and <u>N.J.A.C.</u> 19:41A-5.3; and permitted her to assume the duties and exercise the powers of Vice President of Human Resources for Marina District Development Company, LLC (*d/b/a* Borgata Hotel Casino & Spa), pending plenary qualification; subject to the conditions contained in <u>N.J.S.A.</u> 5:12-85.1 and <u>N.J.A.C.</u> 13:69C-2.6 (PRN 2732501) (Ruling number 25-10-08-16; transcript pages 55-59).

17. Considered the petition of Marina District Development Company, LLC (*d/b/a* Borgata Hotel Casino & Spa) and MGM Resorts International, and issued the following ruling:

By a vote of 3-0, approved the petition and issued a temporary casino key employee license to Nagaraj Sheegihalli, pursuant to <u>N.J.S.A.</u> 5:12-89b(4), <u>N.J.S.A.</u> 5:12-89e and <u>N.J.A.C.</u> 19:41A-5.3; and permitted him to assume the duties and exercise the powers of Vice President, Information Security IAM for Marina District Development Company, LLC (d/b/a Borgata Hotel Casino & Spa), pending plenary qualification; subject to the conditions contained in <u>N.J.S.A.</u> 5:12-85.1 and <u>N.J.A.C.</u> 13:69C-2.6 (PRN 2742501) (Ruling number 25-10-08-17; transcript pages 59-64).
