RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE JOINT PETITION OF TRUMP TAJ MAHAL ASSOCIATES, LLC AND TEI MANAGEMENT SERVICES LLC FOR APPROVAL OF A MANAGEMENT AGREEMENT AND OTHER RELIEF (PRN 0621601)

WHEREAS, casino licensee Trump Taj Mahal Associates, LLC (TTMA), has entered into a management agreement with TEI Management Services LLC (TEI Management) pursuant to which TEI Management will manage the gaming operations of Trump Taj Mahal Casino Hotel (Taj); and

WHEREAS, the Casino Control Act at N.J.S.A. 5:12-86(c) requires that every agreement for the management of a casino shall be in writing and filed with the Division of Gaming Enforcement (Division) and the New Jersey Casino Control Commission (Commission); and

WHEREAS, TTMA and TEI Management have submitted a Management Agreement (the Management Agreement) to the Division and the Commission (P-1 in evidence); and

WHEREAS section 82(c) of the Casino Control Act (Act) further provides that no such management agreement shall be effective unless expressly approved by the Commission; and

WHEREAS TTMA and TEI Management filed a petition on March 2, 2016 with the Division (PRN 0620601) requesting Commission approval of the

Management Agreement and a determination that TEI Management may file as a gaming-related casino service industry enterprise (CSIE); and

WHEREAS the Division filed a report dated April 5, 2016 (D-1 in evidence) responding to the petition and recommending that the Commission grant the requested rulings; and

WHEREAS the Commission considered the entire matter at its public meeting on April 13, 2016;

NOW, THEREFORE, BE IT RESOLVED by the Commission that the Management Agreement is hereby **APPROVED**, based upon and to the extent set forth in the findings and rulings, and subject to the conditions, contained in this resolution, as follows:

FINDINGS and RULINGS

Based upon consideration of the entire record of these proceedings, the Commission issues the following rulings and makes the following findings:

- 1. The Management Agreement complies with each of the requirements for such agreements as set forth in section 82(c)(7) and (10) of the Act; and
- 2. The Management Agreement includes within its terms all provisions reasonably necessary to best accomplish the policies of the Act in accordance with N.J.S.A. 5:12-82(c); and
- 3. TEI Management is designated as a gaming-related csie and shall file the appropriate applications and forms required of a gaming-related csie.

CONDITIONS

Based upon the entire record of the proceedings, the findings and rulings set forth herein are subject to the following conditions:

- 1. TEI Management shall provide the Division with a copy of the Notice of Commencement regarding the effective date of the Management Agreement within five (5) days of execution.
- 2. TEI Management shall provide the Division with all requested information and shall otherwise fully cooperate with the Division in fulfilling its regulatory responsibilities.
- 3. TEI Management shall comply with the requirements of N.J.A.C. 13:69J-1.1, et seq., and although it is not a holding company of a casino licensee under the Act, shall also comply with N.J.A.C. 13:69C-1.1, -1.2, -1.3, -2.3, -2.5, -2.7, -2.8, -2.9(a), -8.1, -8.2 and N.J.A.C. 13:69D-1.4, -1.7(g) and -1.7(j).
- 4. TEI Management shall comply with the Division's financial reporting regulations applicable to casino licensees, including, but not limited to, <u>N.J.A.C.</u> 13:69C-4.1, *et seq.*, where appropriate and as determined by the Division.
- 5. TEI Management, as manager and operator of Taj, shall be held responsible for compliance with all regulatory requirements applicable to casino operations to the same extent as TTMA.

- 6. Within five (5) days of determining whether it will exercise an option to renew the Management Agreement for an additional five (5) year term, TTMA shall notify the Division it has so elected to exercise its renewal option.
- 7. TTMA and TEI Management shall immediately notify the Division if either party seeks termination of the Management Agreement.
- 8. Any material amendment to the Management Agreement is subject to approval by the Commission upon the filing of a petition by TTMA and TEI Management with the Division and an opportunity for the Division to submit a report regarding such changes.
- 9. Any officer or employee of TEI Management or any of its affiliates, other than TTMA, who is assigned to the Taj casino hotel facility to work and maintain a physical presence at the Taj on a consistent and continuing basis shall hold the appropriate valid casino key employee license or casino employee registration in accordance with N.J.S.A. 5:12-7, -9, -89 and -91, or apply for such casino key employee license or casino employee registration as needed, and shall also obtain the necessary multi-casino endorsement pursuant to N.J.S.A. 5:12-91.1.
- 10. The requirements as set forth in the aforementioned conditions shall not be modified or eliminated except with the approval of the Division Director or his designee, with notice of such approval directed to the Chairman of the

Commission. Condition 8 may be modified or eliminated by the Division Director or his designee with the consent of the Chairman of the Commission.
