(GLP), as Landlord, and TEI, as Tenant; and

WHEREAS, the Commission determined at its August 8, 2018 meeting that Tropicana AC Sub Corp. (Trop Sub) was required to hold a casino service industry license pursuant to <u>N.J.S.A</u>. 5:12-82c in connection with serving as Landlord under the Master Lease and approved the Master Lease as compliant with *N.J.S.A*. 5:12-82c et. seq. (Resolution No. 18-08-08-13); and



WHEREAS, at its meeting of September 12, 2018, the Commission granted ERI, together with required qualifying entities and individuals, Interim Casino Authorization to consummate its purchase of TEI pursuant to an Agreement and Plan of Merger (Resolution No. 18-09-12-14); and

WHEREAS, the Division of Gaming Enforcement (Division) by letter report filed February 27, 2019 recommended that the Commission grant the current requested relief with certain conditions; and

WHEREAS, the Commission considered the entire record of this matter at its public meeting on March 6, 2019.

FINDINGS and RULINGS

Based upon consideration of the entire record of these proceedings, the Commission issues the following rulings and makes the following findings:

- 1. TEI is required to hold a casino service industry enterprise license pursuant to N.J.S.A. 5:12-82c in connection with serving as Sublandlord under the Sublease.
- 2. The Sublease is approved pursuant to *N.J.S.A.* 5:12-82c.
- 3. The First Amendment to the Master Lease is approved.



CONDITIONS

- 1. TEI shall provide the Division with all requested information and shall otherwise fully cooperate with the Division in fulfilling its regulatory responsibilities;
- 2. TEI shall comply with the requirements of *N.J.A.C.* 13:69J-1.1, et seq., in addition to compliance with all regulations applicable to it as a holding company of a casino licensee pursuant to *N.J.A.C.* 13:69C-1.1, et. seq.
- TEI shall provide the Commission and the Division with final copies of the Sublease and the First Amendment to the Master Lease within five days of execution;
- 4. TEI shall immediately notify the Division if any party seeks termination of the Sublease or Master Lease;
- 5. Amendments to the Sublease, as well as any further amendments to the Master Lease to the extent such amendments relate to Trop AC, are subject to approval by the Commission upon the filing of a petition with the Division and an opportunity for the Division to submit a report regarding such changes. The Chairman through delegated authority may make a determination on any such amendment petition, following receipt of a responsive Division report, if a proposed amendment does not relate to the "buy-out," "joint and several liability," or "termination" provisions required by *N.J.S.A.* 5:12-82c(5) and (10) and -104b,
