RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE JOINT PETITION OF CAESARS ENTERTAINMENT, INC., HARRAH'S ATLANTIC CITY OPERATING COMPANY, LLC AND BOARDWALK REGENCY, LLC FOR THE ISSUANCE OF A NEW JERSEY CASINO KEY EMPLOYEE LICENSE TO MICHAEL T. SALMON PURSUANT TO N.J.S.A. 5:12-89 AND A WAIVER OF THE NEW JERSEY RESIDENCY REQUIREMENT PURSUANT TO N.J.S.A. 5:12-89b(4) (PRN 0672201)

WHEREAS, casino licensees, Harrah's Atlantic City Operating Company, LLC d/b/a Harrah's Resort Atlantic City ("Harrah's AC'), Boardwalk Regency LLC d/b/a Caesars Atlantic City ("Caesars AC"), and their qualified parent holding company, Caesars Entertainment, Inc. ("CEI") having filed a Petition (PRN 0672201) dated March 7, 2022 seeking the issuance of a casino key employee license pursuant to N.J.S.A. 5:12-89 and a waiver of the residency requirement pursuant to N.J.S.A. 5:12-89b(4); and

WHEREAS, on or about November 17, 2017, Michael T. Salmon filed a renewal application for a casino key employee license (#6902-11) with the Casino Control Commission ("Commission") as required by *N.J.S.A.* 5:12-94h(1); and

WHEREAS, the Division of Gaming Enforcement ("Division") filed a response dated February 1, 2019 to the casino key employee renewal application of Michael T. Salmon in which it indicated no objection to the renewal of Mr. Salmon's casino key employee license but specified that no casino key employee

credential should be issued unless Mr. Salmon demonstrated New Jersey residency; and

WHEREAS, the Division filed a response to PRN 0672201 in which it indicated no objection to the grant of a temporary residency waiver to Michael T. Salmon until June 15, 2022, unless extended; and

WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of March 9, 2022.

NOW, THEREFORE, BE IT RESOLVED by the Commission that the resubmission application of Michael T. Salmon for a casino key employee license is GRANTED and the residency requirement as provided for in N.J.S.A. 5:12-89b(4) is waived through June 15, 2022, which may be extended by request for good cause shown which the Commission Chairman is hereby delegated to determine.
