



RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE PLENARY QUALIFICATION OF MICHAEL JOSEPH CAPPETTA TO SERVE AS SENIOR VICE PRESIDENT OF INTERNAL AUDIT OF MGM RESORTS INTERNATIONAL

**WHEREAS**, on July 7, 2022, the New Jersey Casino Control Commission (“Commission”) granted temporary qualification to Michael Joseph Cappetta to assume the duties and exercise the powers of Senior Vice President of Internal Audit for MGM Resorts International (“MGM”), a qualified holding company of casino licensee Marina District Development Company, LLC d/b/a Borgata Hotel Casino & Spa, for a nine-month period in accordance with the conditions contained in *N.J.S.A. 5:12-85.1* and *N.J.A.C. 13:69C-2.7* (Commission Resolution No. 22-07-07-13); and

**WHEREAS**, the Division of Gaming Enforcement (“Division”) filed a letter report dated January 17, 2023 recommending that the Commission find Michael Joseph Cappetta plenary qualified to serve as Senior Vice President of Internal Audit for MGM; and
