Applicant further has outstanding debts owed to the New Jersey Division of Taxation (NJ Taxation) in amounts last estimated at \$1,249.06 for tax year 2016, \$721.77 for tax year 2017, \$2,836.58 for tax year 2018, \$326.51 for tax year 2019, and \$154.06 for tax year 2020.
- 5. Applicant has enrolled in payment plans with both the IRS and NJ Taxation in the amounts of \$327 and \$223 per month, respectively, and payments under those plans are current.
- 6. It is therefore agreed to and stipulated by and between the parties hereto that:
  - A. The facts stated herein are true and accurate.
  - B. Applicant admits the accuracy of the facts and information set forth in the Division's attached letter report of February 27, 2023.

- C. The Division does not object to a finding by the Commission that Applicant meets all the qualification criteria as set forth in Section 89 of the Act on the conditions that:
  - i. Applicant agrees to continue to make monthly payments of \$327 to the IRS and \$225 to NJ Taxation pursuant to Applicant's payment plans until the debts are satisfied, and further agrees to report to the Division, on an annual basis regarding payments of these debts, including proof of payments, beginning June 15, 2023 until the debts are satisfied.
