WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of August 9, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Commission that David Addleman be issued a temporary casino key employee license, with a waiver of the residency requirement, pursuant to *N.J.S.A.* 5:12-89b(4) and -89e and *N.J.A.C.* 19:41A-5.3 pending plenary licensure.

IT IS FURTHER RESOLVED by the Commission that David Addleman is temporarily qualified and is hereby authorized to assume the duties and exercise the powers of Vice President Regional Technology for MGM subject to the conditions contained in N.J.S.A. 5:12-85.1 and N.J.A.C. 13:69C-2.6 and -2.7.
