The Division of Gaming Enforcement ("Division") having filed an Application for Suspension and a Complaint for Revocation of the casino key employee license, #8281-11, of Keinia Y. Blakeley ("Respondent") on April 3, 2020, as a result of charges filed on March 3, 2020 by the New Jersey State Police (#S-2020-000030-0511); and the Casino Control Commission ("Commission") having entered Order No. 20-05-06-06 granting the Division's Complaint for Suspension of the Casino Key Employee License of Respondent and remanding the Complaint for Revocation to the contested case process; and the contested case process having been deferred pending the resolution of the criminal charges; and Respondent's casino key employee license having lapsed in May 2023 during the deferral period; and the criminal charges against Respondent

having been dismissed by the Superior Court of New Jersey, Cape May County, on October 18, 2023; and the Complaint for Revocation having been removed from deferral status; and a Settlement Conference with the Division and Respondent having been held on March 13, 2024; and the Division and Respondent having entered into a Stipulation of Settlement ("Stipulation") which was submitted to the Commission; and the Commission being unaware of Respondent having been involved in any other matter inconsistent with the terms of the Stipulation; and the Commission having considered this matter in its entirety at its public meeting on August 14, 2024;

IT IS on this 14th day of August 2024, ORDERED that the Stipulation of Settlement between the Division and Respondent signed and dated August 2, 2024, by Respondent, and August 5, 2024, by Jocelyn R. Fietkiewicz, Deputy Attorney General, for the Division, and incorporated herein by reference, is hereby **APPROVED**; and

IT IS FURTHER ORDERED that consistent with the terms of the approved Stipulation of Settlement, the Division's Complaint for Revocation of Respondent's prior casino key employee license, #8281-11, is WITHDRAWN, and Respondent is hereby permitted to file an application for an initial casino key employee license and/or an

application for casino employee registration immediately upon the entry of this Order, with the Division reserving the right to initiate legal action or object to a future application for casino key employee licensure or casino employee registration, without limitation based on subsequent developments which may affect Respondent's suitability for licensure.
