WHEREAS, on June 12, 2024, the New Jersey Casino Control Commission (“Commission”) granted temporary qualification to David B. Zerfing to permit him to assume the duties and exercise the powers of Vice President of Finance and Chief Financial Officer (“CFO”) for casino licensee, Golden Nugget Atlantic City, LLC, (“GNAC”) for a nine-month period in accordance with the conditions contained in *N.J.S.A. 5:12-85.1* and *N.J.A.C. 13:69C-2.6* and issued David B. Zerfing a temporary casino key employee license pursuant to *N.J.S.A. 5:12-89b(4)* and *-89e* and *N.J.A.C. 19:41A-5.3* (Commission Resolution No. 24-06-12-14); and

WHEREAS, the Division of Gaming Enforcement filed a Letter Report dated January 2, 2025, recommending that the Commission issue an initial casino key employee license to David B. Zerfing and find him plenary qualified to serve as Vice President of Finance and CFO for GNAC;
