RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION RECOGNIZING THE 30TH ANNIVERSARY OF THE VIRGIN ISLANDS CASINO CONTROL COMMISSION

WHEREAS, on November 3, 1995, Bill No. 21-0027, known as the Virgin Islands Casino and Resort Control Act of 1995, landmark legislation that authorized casino resorts to stimulate the economy of St. Croix, the largest island in the United States Virgin Islands, was signed into law; and

WHEREAS, this Act established the Virgin Islands Casino Control Commission to provide regulatory oversight of the gaming industry by assuring the good character, honesty and integrity of all licensed operators and employees and related businesses; by protecting the gambling and gaming industry from the influence of criminal activity; and by fostering public confidence and trust in the activities of the gambling and gaming industry; and

WHEREAS, since 1995 the New Jersey Casino Control Commission has maintained a collaborative partnership with the Virgin Islands Casino Control Commission, and under the leadership of its first chairperson, the late Honorable Eileen Ramona Petersen, provided training to its newly hired regulatory personnel to support development of rules and compliance standards for the Virgin Islands casino gaming industry; and

WHEREAS, on December 2, 1998 the Virgin Islands Casino Control Commission issued its first casino license to Treasure Bay VI Corporation and on March 14, 2000, the first casino, The Divi Carina Bay Casino, was officially opened, and on February 1, 2016, it approved the operation of a casino in the newly refurbished Caravelle Hotel, a landmark along the Christiansted Harbor; and

WHEREAS, the Virgin Islands Casino Control Commission engages in training, educational conferences and continuous study, to remain informed regarding current regulatory practices and

procedures including the promotion of responsible gaming, through the launch in March 2025 of www.playwisevi.org, a website dedicated to raise awareness about problem gambling, and the hosting of the Virgin Islands Internet Gaming and Internet Gambling Summit in July 2025, focused on the legislative landscape surrounding internet and mobile/retail sports wagering; and

WHEREAS, the Virgin Islands Casino Control Commission's efforts have created a safe and secure environment for casino gaming, generating significant revenue and employment opportunities for the Territory and local communities; and
