WHEREAS, on or about February 18, 2026, Dominic Hammond completed and filed a Multi-Jurisdictional Personal History Disclosure (PHD -MJ) Form and New Jersey Supplemental Form with the Division of Gaming Enforcement (“Division”) as required by *N.J.A.C. 13:69C-2.7(c)*; and


treatment programs all have significant positive impacts on gamblers, their families and society as a whole; and


