Mr. Connery read the Open Public Meetings announcement and performed the roll call of the Board.

Because a quorum was not met Chairman Inverso requested that the financial report be presented.

Financial Report

Jeff Koval from the Department of Treasury's Division of Administration stated that there were only nominal changes to the CCRC banking statement due to interest and a slight increase in insurance.

Staff Update - EDA Real Estate Division Presentation

Stephen Martorana and Juan Burgos presented the Trenton State Office Feasibility Study. (attached)

Call to Order:

With a quorum of Members now present, Chairman Peter Inverso called the meeting to order at 10:25 a.m.

Meeting Minutes:

The Board was presented with meeting minutes from the Board of Directors' May 18, 2016 Annual meeting. A motion to approve the May 18, 2016 annual meeting minutes was made by Robert Prunetti, seconded by Andrew Swords and approved by the Board in a vote of 6-0-0.

Capital Park Presentation – John Hatch

John Hatch, Principal, Clark Caton Hintz presented plans relating to the Capital State Park located behind the State House building, a project that was halted several years ago due to funding issues.(attached) Mr. Hatch stated that with all of the exciting happenings in Trenton currently, it is a good time to for the State to revisit the park project. Mr. Hatch stated that he had spoken with the Lieutenant Governor recently, and while she was not familiar with the project, seemed open to discussion on finding funds to advance the project.

Chairman Inverso suggested that the next Board meeting be used as a strategic planning session to go over and possibly refresh the Renaissance Plan in order to provide the State, in particular the Lieutenant Governor with up to date detailed information on revitalization projects CCRC would advocate for within the City. A request to meet with the Lieutenant Governor would follow the session.

Chairman Inverso requested copies for the Board of the CCRC Revitalization Plan.

Diana Rogers entered the meeting.

City of Trenton Update - Diana Rogers

Diana Rogers updated the Board on progress against the façade improvement program as well as the Ajax Development projects. Ms. Rogers also spoke about the upcoming Greater Trenton/NJ Partnership for Action event at Thomas Edison State University, to which the Board Members were invited and encouraged to attend.

Ms. Rogers also informed the board of the new branding for Trenton Business Week which will now be Trenton Business Innovation Project and will follow a new format. The website should be up and running shortly.

Maureen Hassett updated the group on the recent Grow NJ award to The Hibbert Group in Trenton that retained over 250 jobs for the City.
