##### **Notice of Availability of Funds**

##### **Purchase of Residential Community Reintegration Program Services**

**Take notice** that, in compliance with N.J.S.A. 52:14-34.4, 34.5, and 34.6 (P.L. 1987, c. 7), the Department of Corrections (Department), Division of Programs and Reintegration Services, hereby publishes a notice of availability of funds.

**Name of program:** Residential Community Reintegration Programs.

**Purpose for which the funds will be used:** To contract with nonprofit corporations for Residential Community Reintegration Programs for Incarcerated Persons committed to the New Jersey Department of Corrections.

**Funding period:** Successful applicants will be awarded a two-year contract with a service commencement date of August 1, 2025. The New Jersey Department of Corrections has the sole discretion to award a one-year contract extension based upon performance. If a one-year contract extension is awarded, the contract term would be three years.

**Amount of funding available:** The total Fiscal Year 2025 appropriation for Residential Community Reintegration Programs is \$49,923,996. The Department's Fiscal Year 2026 budget request for the appropriation of funds for Residential Community Reintegration Programs will be subject to approval by the Office of Management and Budget and the State Legislature. The final Fiscal Year 2026 appropriation amount will not be known until late June 2025.

**Groups or entities that may apply:** Nonprofit community-based corporations or associations.

**Qualifications needed by applicant agency to be considered for a grant:** Nonprofit corporations must have suitable facilities that conform to local building codes and zoning ordinances and meet local and State health and fire codes.

**Procedure for eligible entities to apply for funds:** Qualified applicants must complete and submit a proposal as outlined in the Residential Community Reintegration Programs Request for Proposals. Eligible and interested organizations may obtain a copy of the Request for Proposals from the New Jersey Department of Corrections' website beginning April 7, 2025, at:

**Deadline by which proposals must be submitted:** Proposals must be submitted no later than 12:00 P.M. on May 9, 2025.
