On 10/25/24, Bayside State Prison's Senior Correctional Police Officer (SCPO) Robert Currey was charged with violating NJSA 2C:29-2A (3)A, Resisting Arrest. While being placed in custody, SCPO Currey pushed a New Jersey State Trooper and resisted entering the back seat of the Trooper's vehicle. Furthermore, SCPO Currey failed to provide the required follow-up documentation related to the incident within the time frames required by the New Jersey Department of Corrections (NJDOC). On 4/29/25 the New Jersey Police Training Commission suspended SCPO Currey's law enforcement license pursuant to the Police Licensure Act, NJSA 52:17B-66, et seq. SCPO Curry resigned from the NJDOC on 11/25/25.

On 11/2/24, SCPO Gansert opened a "sick number" and stopped reporting to work. SCPO Gansert inaccurately advised operations that his retirement was effective 11/1/24. SCPO Gansert was advised by New Jersey Department of Corrections (NJDOC) Human Resources (HR) that he did not have an approved leave and would need to either return to work or submit FMLA documentation to cover his absences. SCPO Gansert failed to respond to repeated correspondence from NJDOC HR. SCPO Gansett was issued a Final Notice of Disciplinary Action for a resignation not in good standing, effective 2/18/25.

On 10/14/25, Bayside State Prison's Senior Correctional Police Officer (SCPO) Michael Kuzmicz was issued a Preliminary Notice of Disciplinary Action for knowingly purchasing and possessing multiple high capacity magazines, which are illegal to own in the State of NJ. An investigation conducted by the New Jersey Department of Correction's Special Investigations Division (SID) revealed that SCPO Kuzmicz owned four high capacity thirty round .556 magazines and three high capacity, thirty round .762 magazines. The Cumberland County Prosecutor's Office declined to pursue criminal charges regarding the firearms confiscated from SCPO Kuzmicz. On 11/6/25, SCPO Kuzmicz signed a settlement agreement for a 60-day suspension.

E1- Violation of a rule, regulation, policy, procedure, order or	On 7/18/25, while assigned as the supervising Senior Correctional Police Officer (SCPO) of Bayside State Prison (BSP) Highway Detail #136, SCPO Paul Ricci was approached by a former incarcerated person during detail on Route 55. SCPO Ricci did not report this interaction. The Special Investigation Division (SID) received the Global Positioning System (GPS) of the vehicle assigned to BSP Highway Detail #136. The GPS records showed that the vehicle was at 261 East Point Road, Maurice River (East Point Lighthouse) on six occasions and this location was not in the logbook and not part of the deployment records. During the SID investigation, SCPO Ricci stated that he transported the incarcerated persons to the East Point Lighthouse to show them the difference between an osprey and an eagle. SCPO Ricci signed a settlement agreement for a 90-day suspension on 9/29/25.

Abandonment of job as a result of absence from work as scheduled without permission for five consecutive work days	On 1/18/25, the Division of Pensions informed Bayside State Prison's Senior Correctional Police Officer (SCPO) Sharon Williams (who had filed for disability retirement on 6/30/23) that her retirement application was closed due to submission of insufficient documentation. After failing to respond to repeated correspondence from the New Jersey Department of Corrections Human Resources office, SCPO Williams was issued a Final Notice of Disciplinary Action for resignation not in good standing on 3/1/25.

GCPO served a search warrant and confiscated SCPO Williams's phone, computers and various electronic equipment. Following GCPO's decision to not pursue criminal charges, SID conducted an investigation. GCPO provided SID with images of SCPO Williams in his New Jersey Department of Corrections uniform in a bathroom, armed with his handgun, taking a photo of himself with his penis exposed while on duty at Inspira Medical Center. SID was provided with a recovered photo depicting the Bayside State Prison yard capturing the secured perimeter with incarcerated persons present in the photo. This photo was taken while SCPO Williams was on duty working the tower post at Bayside State Prison. During the course of the investigation, SCPO Williams also admitted to failing to report a prior interaction with detectives from Cumberland County Prosecutor's Office. SCPO Williams signed a settlement agreement for retirement
