During this time, the facility was left short staffed, creating a safety and security risk. SCPO Boswell stated he left the facility to pick up medication for his children, but he was unable to produce a receipt or any confirmation of this. SCPO Boswell signed a settlement agreement on 8/6/25 for a 30-day suspension.  |

SCPO Coiro repeatedly cursed at the Wayne Township Police officers, laughed at them, called them "rookies," and further failed to cooperate with law enforcement. At the police station, SCPO Coiro refused a breathalyzer. He was also combative and evasive. SCPO Coiro signed a settlement agreement on 2/11/25 for a 60-day suspension. |

SCPO Dixon failed to report for duty in a timely manner, arriving approximately one hour late. The institution had reported critical staffing levels for that day. When questioned by a sergeant as to her location, SCPO Dixon stated she was in her car; however, no permission from a supervisor to exit the secured perimeter was given. It was also determined that SCPO Dixon was insubordinate during her conversation with the sergeant questioning her whereabouts. She acted unprofessional, used profane language, and failed to follow orders as directed by her supervisor. SCPO Dixon signed a settlement agreement for a 10-day suspension on 2/21/25.                  |

An investigation determined that between 1/1/20 and 1/7/21, while on duty, SCPO Gramajo smuggled contraband into NSP to a particular incarcerated person and was paid cash in return. On 9/22/25, SCPO Gramajo pleaded guilty to one count of criminal Conspiracy N.J.S.A 2C:5-2a (1)- Conspiracy and agreed to the forfeiture of his public employment. On 10/6/25, SCPO Gramajo was terminated from employment with the New Jersey Department of Corrections. |

SCPO Hidalgo failed to report to medical, fill out the required forms necessary for early release, and did not follow proper call off procedures. SCPO Hidalgo signed a settlement for a 30-day suspension on 3/10/25.   |

SCPO McGee refused the orders of a Correctional Police Lieutenant (CPL) to pat down a female custody and civilian staff members as they entered the secured perimeter. SCPO McGee stated that she would not pat down anyone unless a supervisor was present. This caused a CPL to conduct the pat down searches and for SCPO McGee to be pulled from the post and reassigned. SCPO McGee signed a settlement agreement for a 10-day suspension on 10/20/25.   |

Although this incident was declined by the Prosecutor's office for prosecution as a criminal matter, SCPO Mendoza utilized a closed fist strike at the incarcerated person who at the time appeared to be a passive resister. SCPO Mendoza stated he perceived the incarcerated person as "Lurching" towards him when the gate opened which was not clear on body worn camera footage. SCPO Mendooza did not appear give any clear verbal orders to the incarcerated person to turn around and back out of the gate prior to the use of force by SCPO Mendoza. The incarcerated person responded to the strike and took a fighting stance and engaged the officers. The actions of SCPO Mendoza appeared to have caused the incident to escalate. On 7/29/25, Use of Force Review Committee conducted a review of the incident and deemed the force utilized by SCPO Mendoza was not proportional to the resistance presented by the incarcerated person. SCPO Mendoza signed a settlement agreement for a 20-day suspension on 10/7/25. |

An investigation revealed that SCPO Ortiz failed to log herself into the logbook as required. SCPO Ortiz signed a settlement agreement for a 10-day suspension on 8/23/25.  |
