**Summary** of Public Comment and Agency Response:

No comments were received.

**Summary** of Agency-Issued Change upon Adoption:

Following publication of the notice of proposed readoption with amendments, repeal, and

new rule, the Department of Corrections (Department) became made aware that the telephone

number in the rules for the Corrections Ombudsperson was incorrect and that the Office of the

Ombudsperson had added two new toll-free numbers for inmates in Residential Community

Reintegration Programs and for the general public to call. The Department is making agency-

issued changes upon adoption to make these corrections. Please note that the telephone number

requiring correction appeared in the rules proposed for readoption with amendments, repeals, and new rules only. The correct number appeared in all literature and notices from the Office of the Ombudsperson available to inmates in correctional facilities. The agency-issued changes are at N.J.A.C. 10A:1-1.3(b) adding a colon and new bullet point "i" following "free call," using the remainder of the sentence without change except the phone number at the end, which has been replaced with (609) 633-2596. Two additional toll-free numbers have also been added to provide further access to the Ombudsperson and are being added to the rules at N.J.A.C. 10A:1-1.3(b)ii and iii.

## **Federal Standards Statement**

The rules readopted with amendments, a repeal, and a new rule are promulgated pursuant to the authority of the rulemaking requirements of the Department of Corrections, as established at N.J.S.A. 30:1B-6 and 30:1B-10. The rules readopted with amendments, a repeal, and a new rule are not subject to any Federal statutes, requirements, or standards; even though they include processes related to the Americans with Disabilities Act, those processes are in compliance with the Act and a Federal standards analysis is not required.
