- 1. COMMENT: The commenters state that the proposed regulation "should not be applicable to persons detained at the ... Special Treatment Unit" (STU) because, according to the New Jersey Sexually Violent Predator Act, they are not "inmates." The commenters oppose the proposal. RESPONSE: The Department acknowledges that persons committed to the STU pursuant to the New Jersey Sexually Violent Predator Act are residents and not inmates. The Department disagrees, however, that the rules pertaining to its smoking cessation policies and programs should not apply to residents in the STU. Unless otherwise stated, the provisions of Title 10A apply to inmates and STU residents alike, pursuant to N.J.A.C. 10A:1-2.1.

The Department's non-smoking policy pertains to all NJDOC facilities, including the STU. The Department is responsible for the operation of the STU and for the custody, care, and control of STU residents. See N.J.A.C. 10A:35-1.1. Further, it should be noted that the New Jersey Smoke-Free Air Act, which prohibits indoor smoking in public places or workplaces, applies to all State buildings including the STU. Accordingly, the rules prohibiting the smoking, use, or possession of tobacco products or associated tobacco paraphernalia in all NJDOC facilities, are applicable to inmates and STU residents alike. Both inmates and STU residents are housed in NJDOC facilities. The Department notes, however, that STU residents are not subject to the provisions of N.J.A.C. 10A:4 regarding inmate discipline. See, for example, N.J.A.C. 10A:1-2.2 and 10A:4-5.1.

Federal Standards Statement

The rules readopted with amendments are promulgated under the authority of the rulemaking requirements of the Department of Corrections as established at N.J.S.A. 30:1B-6 and 30:1B-10. The rules readopted with amendments are not subject to any Federal statutes, requirements, or standards; therefore, a Federal standards analysis is not required.
