<p>Under the direction of the supervisor of chaplaincy services or other supervisory official in a state correctional institution, department, institution, or agency, assists with the coordination and provision of spiritual and religious services to residents, incarcerated individuals, and employees of ALL faiths and denominations; does other related duties as required.</p> <p>More Specificaly, Chaplains will be required to preside over the worship service, for which they are properly trained and credentialed. Additionally, when Chaplains are not trained or credentialed in a specific faith denomination, they will be required to visually supervise the incarcerated population when they are permitted to gather for self-led services. Fulltime Chaplains are required to work one evening per week. Telework is not available for this position.</p> <p>NOTE: The services of the incumbent in this position will be predominantly available for incarcerated individuals within an institution; however, they may be extended to the employees in extreme circumstances as deemed appropriate.</p>			
REQUIREMENTS			
<p>EDUCATION: Graduation from an accredited college, university, or seminary with a bachelor's degree.</p> <p>NOTE: Graduation from a course of theological study as required by the ordaining or endorsing body.</p> <p>EXPERIENCE: Two (2) years of experience as a minister, priest, rabbi, imam, or deacon in the offices of a religious faith, which shall have included religious, personal, and social counseling, with one (1) year of supervised pastoral counseling (such as clinical pastoral education) in an institutional setting.</p> <p>NOTE: Applicants who do not possess the required degree may substitute additional experience as indicated above on a year-for-year basis.</p> <p>NOTE: A Master of Divinity Studies or similar programs may be substituted for one (1) year of relevant experience.</p> <p>LICENSE: Appointees will be required to possess certification or accreditation as a minister, priest, rabbi, imam, or deacon in an established religious faith, and an endorsement for chaplaincy where required by the ordaining or endorsing body.</p> <p>Credentials will be examined in the context of the Chaplain candidate's faith denomination.</p> <p>Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.</p> <p>RESIDENCY REQUIREMENT: Newark residents receive first hiring preference</p>
