So the Division of Law can conclude our review of Supplement 1 to Waiver AN-072, kindly confirm our understanding that the agreement previously entered into between your company and the State will remain in effect through the extension of the waiver, as follows:

The Agreement executed by Active on June 10, 2020, between Active and the State of New Jersey, Department of the Treasury, Division of Purchase and Property, on behalf of the State of New Jersey, Department of Property Management and Construction (the "Agreement"), and each of the documents referenced in paragraph 1 of the Agreement, are and shall be extended and shall continue in full force and effect for the period of July 1, 2020 through June 30, 2021 in connection with Supplement 1 to Waiver AN-072 for cleaning and disinfecting services for State of New Jersey buildings with instances of COVID-19 positive or presumptive positive cases and any subsequent supplements to Waiver AN-072, except to the extent amended, supplemented or replaced by a written agreement of the parties.
