Kimberly Mitchell, represented by Herbert J. Stayton, Jr., Esq. requests enforcement and back pay pursuant to *In the Matter of Kimberly Mitchell* (CSC, decided January 15, 2025).

ACTION: The Civil Service Commission held these matters over for further review.

B-8 S.J. – CSC DOCKET NO. 2025-2426

Boonton, represented by Anthony G. LoBrace, Esq., petitions the Civil Service Commission for a stay of *In the Matters of S.J., Boonton* (CSC, decided March 19, 2025), which granted S.J.'s request for enforcement in part, pending the outcome of its appeal to the Superior Court, Appellate Division.

ACTION: The Civil Service Commission directed that this petition be denied.

Christopher Boller, a Police Captain with Ewing, represented by Peter B. Paris, Esq., petitions the Civil Service Commission for interim relief of his demotion.

B-10 PATRICK GEARY AND CHARLES DISHON – CSC DOCKET NOS. 2025-2411 AND 2025-2480

Patrick Geary and Charles Dishon appeal the disposition of the February 21, 2025 certification of the County Correctional Police Lieutenant (PC1693A), Ocean County, eligible list.

B-12 INTERMITTENT PUBLIC SAFETY TELECOMMUNICATOR – CSC DOCKET NO. 2025-2752
