FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Todd Caton, Traffic Signal Supervisor 1 (PC0480S), Ocean County

CSC Docket No. 2015-375

Examination Appeal

Todd Caton appeals the determination of the Division of Selection Services (Selection Services) that, per the substitution clause, he was below the minimum requirements in experience for the promotional examination for Traffic Signal Supervisor 1 (PC0480S), Ocean County.

The examination at issue was announced with specific requirements that had to be met as of the March 21, 2014 closing date (see attached). Mr. Caton was the only employee who applied for the subject examination that was cancelled due to a lack of qualified candidates.

On Mr. Caton's application, he indicated that he was provisionally serving in the title under test from March 2012 to the March 21, 2014 closing date, an Assistant Supervisor, Traffic Maintenance from November 2006 to March 2012, a Traffic Signal Technician 1 from May 2003 to November 2006, a Senior Traffic Maintenance Worker from January 2001 to May 2003, a Traffic Maintenance Worker from May 1999 to January 2001, a Laborer 1 from September 1998 to May 1999, a Traffic Maintenance Worker from November 1997 to September 1998, and a Laborer 1 from May 1995 to November 1997. Personnel records indicate that the appellant was provisionally serving in the subject title from March 2012 to the March 21, 2014 closing date, an Assistant Supervisor, Traffic Maintenance from September 2003 to March 2012, a Traffic Signal Technician 1 from May 2003 to September 2003, a Senior Traffic Maintenance Worker from September 2000, a Laborer 1 from September 1998 to June 1999, a Traffic Maintenance Worker from November 1998 to June 1999, a Traffic Maintenance Worker from November

1997 to September 1998, and a Laborer 1 from May 1995 to November 1997. Selection Services credited Mr. Caton with two years and one month of general and supervisory experience based on his provisional experience in the subject title and an additional five months of experience as a Traffic Signal Technician 1, but determined, per the substitution clause, that he lacked two years and six months of general experience.

On appeal, Mr. Caton states that he has 11 years of experience and he submits Traffic Signal Inspector and Traffic Signal Field Technician training certificates that he has earned. The appellant maintains that although his permanent title is Assistant Supervisor, Traffic Maintenance, he is performing the duties of the subject title. Mr. Caton presents that his current daily responsibilities consist of supervising traffic signal repair crews along with the maintenance, emergency trouble shooting and installation of all country traffic signals. The appellant also represents that as an Assistant Supervisor, Traffic Maintenance, he trained signal technicians and others on how to properly install traffic signals and worked with various personnel to maintain the over 400 county traffic signals.

CONCLUSION

N.J.A.C. 4A:4-2.6(a) provides that applicants shall meet all requirements specified in the promotional announcement by the closing date. N.J.A.C. 4A:4-2.1(g) provides that the Civil Service Commission (Commission) can accept clarifying information in eligibility appeals. Further, N.J.A.C. 4A:1-1.2(c) states that the Commission may relax a rule for good cause in order to effectuate the purposes of Title 11A, New Jersey Statutes.

Initially, Selection Services correctly determined that Mr. Caton was not As of the announced closing date, the eligible for the subject examination. appellant's application did not indicate that he had five years of experience where his primary responsibility was work involving the installation, maintenance and repairs of electrical or electronic components, equipment or systems. In accordance with N.J.A.C. 4A:4-2.1(g), the Commission can accept clarifying information in eligibility appeals. Furthermore, N.J.A.C. 4A:4-2.1(f) provides that an application may only be amended prior to the announced closing date. For example, information submitted on appeal pertaining to duties in a given position that expands or enlarges information previously submitted is considered clarifying and is accepted. However, any documentation indicating work in a setting that was not previously listed on an application or resume cannot be considered after the closing date. Thus, the Commission can only consider information provided on appeal regarding the positions listed on the appellant's original application. See In the Matter of Diana Begley (MSB, decided November 17, 2004). Although the information on his original application did not precisely mirror the requirements, Mr. Caton clarified his application by explaining that, in addition to his provisional experience in the subject title and as a Traffic Signal Technician 1, as an Assistant Supervisor, Traffic Maintenance, his responsibilities included training personnel on the installation of traffic signals and that he supervised and worked with personnel in the maintenance of traffic signals. Additionally, the appellant possesses training certificates as a Traffic Signal Inspector and as a Traffic Signal Technician. Furthermore, Mr. Caton continues to serve provisionally in the subject title and this is not a competitive situation as he was the only applicant for the subject examination. Under these circumstances, good cause exists to relax the provisions of N.J.A.C. 4A:4-2.6(a) and accept the appellant's clarifying information that he provided on appeal as well as the totality of his experience as far back as May 2003 and his certifications and admit him to the subject examination. Accordingly, admitting Mr. Caton to the subject examination will provide the appointing authority with an eligible list so that it can make a permanent appointment.

ORDER

Therefore, it is ordered that the appeal be granted, and the appellant's application be processed for prospective employment opportunities only.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

Or to employees in the competitive division who have an aggregate of one year of continuous permanent service as of the closing date in any competitive title and meet the requirements listed below:

Education: Completion of a vocational, technical or specialized training program in electrical or electronic technology. If you have the required certification, you must indicate this on your application; proof of the certification must be submitted with your application. Failure to do so will result in rejection from the examination process.

Experience: Three (3) years of experience in work involving the installation, maintenance and repair of electrical or electronic components, equipment or systems. One (1) year of the required experience shall have been in a supervisory or leadworker capacity.

License: Appointees must possess valid driver's license issued by the New Jersey Division of Motor Vehicles. Proof of license must be submitted to appointing authority prior to appointment.

Appointees may also be required to possess a valid Commercial Driver's License (CDL) Class B for the class and type of vehicle being operated. The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.

Appointees may be required to possess a FCC General Radiotelephone Operator License, Radio Industry Competency Certificate or equivalent license or certification specific to radio operation and repair.

Applicants who do not possess the required education may substitute two (2) years of additional nonsupervisory experience.
