Shikeya Walker-Baldwin, represented by Bilal Hill, Esq., appeals the attached determination of the Division of Classification and Personnel Management¹ (CPM) which found that the appointing authority had presented a sufficient basis to retain her name on the eligible list for Senior Community Program Specialist (S0090P), Department of Human Services for future certifications only.

By way of background, the subject list of 110 eligibles promulgated on August 30, 2012 and expires on August 29, 2015. The appellant's name was certified from the list on September 3, 2013 (OS130577) for a position with the Division of Developmental Disabilities in Passaic County. In disposing of the certification, the appointing authority indicated that the appellant's name should be retained since it had received a letter from the appellant indicating that she would like to be retained on the list. Therefore, the appellant was not selected for appointment and her name was retained on the list as being interested in future certifications only. Subsequently, the appellant appealed this determination to CPM, arguing that she never responded to the certification indicating that she was not currently interested in the position. The appellant also requested copies of the materials the appointing authority provided in support of its request to retain her name for future certifications. In response, CPM provided the appellant a copy of an undated letter date stamped as received by the Division of Developmental Disabilities Human Resources on September 11, 2013. That letter indicated:

I, Shikeya Walker am writing to the Appointing Authority this letter that I would like to be retained on the list for Passaic County Senior Community Program Specialist. Certification No. OS130577.

The letter contained an illegible signature over the appellant's hand-printed name. Based on this documentation, CPM determined that the appellant's name was properly retained on the eligible list.

On appeal, the appellant asserts that she did not write the letter to the appointing authority stating that she would like to be retained on the list for future certifications. In this regard, she claims that her signature was forged on the correspondence provided to CPM requesting the retention of her name on the list. Additionally, the appellant states that she sent a letter of interest in the position to the appointing authority on September 13, 2013, which is two days after the date stamped on the letter she claims was fraudulently provided to the appointing authority. The appellant adds that she can show that the signature on the letter is fraudulent with the assistance of a handwriting expert and contends that the appointing authority resorted to forgery in order to prevent her from being appointed. In support of her appeal, the appellant provides copies of certified mail receipts indicating that she sent certified mail to the appointing authority on September 13, 2013. Therefore, the appellant requests a hearing since there is a material and controlling dispute of fact in this matter.

Despite being provided with the opportunity, the appointing authority did not provide a response.

According to agency records, certification OS130577 contained the names of 13 eligibles. The eligibles in the 1st and 2nd positions on the certification were recorded as interested but bypassed. The eligibles in the 3rd through 6th positions, including the appellant, who was in the 4th position, were recorded as being interested in future certifications only. The individuals in the 7th and 9th positions were appointed effective November 30, 2013, the individuals in the 8th and 12th positions were removed for not responding to the certification and the remaining individuals were listed as interested but not reachable or responded late to the certification notice. It is also noted that the notice date on the Notification of Certification for OS130577 is September 10, 2013.

DISCUSSION

In this matter, the appellant states that she sent a letter of interest in the position in response to certification OS130577 to the appointing authority on September 13, 2013. However, the appointing authority provided this agency with a letter purportedly provided by the appellant indicating that she would like to be retained on the list that is date stamped as received in the human resource office on

September 11, 2013. The appellant denies that she sent this letter to the appointing authority and maintains that the undated letter provided to the appointing authority is fraudulent. Given that the appointing authority has not provided the Commission with any additional information or arguments concerning this matter, in conjunction with the fact that the appellant was reachable for appointment consideration but two lower ranked eligibles were appointed, this matter cannot be decided on the written record. Therefore, the Commission refers this matter to the Office of Administrative Law for a hearing concerning the appellant's allegations regarding the letter provided to this agency by the appointing authority in disposing of certification OS130577.

ORDER

The Commission orders that this matter be referred to the Office of Administrative Law for further proceedings as set forth above.

You must submit all proofs, arguments and issues which you plan to use to substantiate the issues raised in your appeal. Please submit a copy of this determination with your appeal to MSPLR. You must put all parties of interest on notice of your appeal and provide them with copies of all documents submitted for consideration.

Please be advised that pursuant to P.L. 2010, c.26, effective July 1, 2010, there shall be a \$20 fee for appeals. Please include the required \$20 fee with your appeal. Payment must be made by check or money order only, payable to the NJ CSC. Persons receiving public assistance pursuant to P.L. 1947, c. 156 (C.44:8-107 et seq.), P.L. 1973, c.256 (C.44:7-85 et seq.), or P.L. 1997, c.38 (C.44:10-55 et seq.) and individuals with established veterans preference as defined by N.J.S.A. 11A:5-1 et seq. are exempt from these fees.
